## **Synopsis of House Joint Memorial 6**

House Joint Memorial 6 (HJM6) expresses support for strengthening relations between Taiwan and both the United States and New Mexico, particularly in trade, education, and diplomatic exchanges. HJM6 encourages strengthening relations with Taiwan, official visits, expanded US-Taiwan trade relations, and educational initiatives with Taiwan.

This bill does not contain an effective date and, as a result, would go into effect 90 days after the Legislature adjourns if enacted, or June 20, 2025.

HJM6 contains no appropriations and no known fiscal impact.

## SIGNIFICANT ISSUES

The Economic Development Department (EDD) opened a trade bureau office in Taipei City, Taiwan in 2021. The office is responsible for working with Taiwanese companies interested in expanding or relocating to New Mexico, potential importers of agriculture products, and coordinating site visits. EDD also signed a memorandum of understanding on trade and economic cooperation with the Taiwanese Ministry of Economic Affairs in 2021 to promote trade relations, help ease global supply-chain pressures, and boost job-growth along New Mexico's international border. Since 2021, EDD has awarded four Taiwanese companies—Admiral Cable, Xxentria, Cymetrik, and Hota—with funding from the Local Economic Development Act fund to support business expansions and relocations in the Santa Teresa border area.
