

# **Construction Costs and Unspent Capital Funds Continue to Soar**

Requests for capital project funding from public school districts and higher education institutions indicate a dramatic rise in construction costs over just the past year, despite stabilization of the supply chain and an easing in the increases to materials costs seen during the pandemic. Recent requests for construction funding to the Public School Capital Outlay Council have come in at double estimates made a year ago. Similarly, requests for 2024 higher education projects are based on construction cost estimates that have roughly doubled since the last general obligation bond request cycle.

**Key Points** 

- Another steep increase in construction costs will make it difficult for the state to meet its many infrastructure needs, despite unprecedented sums available for capital projects. Rising costs are also likely to exacerbate the dilemma of unspent funds across some 5,100 capital appropriations that are currently active in the state.
- At the end of FY23, LFC estimates outstanding capital funds totaled approximately \$5.2 billion, including projects authorized by the Legislature (\$2.9 billion), projects funded through severance tax bond earmark programs (\$500.4 million), supplemental severance tax bonds for public school construction (\$1.3 billion), and special appropriations to capital projects (\$524 million). The last figure represents uncommitted and unspent funds from \$977.4 million in special appropriations during the 2021 special and 2022 regular sessions.
- A focused effort to address chronic problems that compromise the success of projects, such as piecemeal funding, could put the state in a better position to maximize the benefits it generates from capital spending in this challenging environment.


the Department of Finance and Administration, state and local entities, and the Capital **Project Monitoring** System. Outstanding balances reported in this memo reflect expenditures as of May 2023 and do not include encumbered but unspent funds, with the exception of balances reported for special appropriations. Due to the transition to an new reporting system, LFC did not have access to June 2023 expenditure data for legislativelyauthorized projects nor project status updates for the \$1 million and greater report. LFC staff expect to resume producing that report next quarter, when the necessary data should be available again.

#### What's Driving Ongoing Cost Increases?

Cost increases no longer appear to be driven primarily by spikes in material costs or supply chain disruptions, both of which have stabilized. Instead, an extraordinarily busy construction market, a limited labor pool to meet demand, and other sources of uncertainty for contractors appear to be more significant factors. Increased state funding for capital projects is one source of the high demand.

### Cost Increases in New Mexico Appear to Exceed National and Regional Trends


LFC and LESC analysis suggests the recent cost increases for public school and higher education projects in New Mexico are more significant than those occurring in other markets. The cost of public school construction in New Mexico closely followed the Coldwell Banker Richard Ellis cost index, for example, until this year. Had costs in the state continued to track with the

index, the cost per square foot for a new public school would have been around \$437 this year. Instead, four school projects in 2023 have averaged \$771 per square foot.

Similarly, the per-square-foot costs reflected in the higher education institution project requests received this summer by the Higher Education Capital Outlay Committee appear in absolute terms to exceed the cost of such projects in neighboring markets. The average cost of the new requests – at roughly \$1,000 per square foot for new construction – exceeds the highest end cost of higher education projects in three of four other markets. The cost estimates from other markets are based on the RLB Construction Cost Indicator for specific project types in certain markets, plus 30 percent to account for soft costs.

Chart 4. Estimated Total Project Cost Per Square Foot for Higher Education Projects in NM vs. Regional Markets




#### Implications for 2024 Appropriations and Legislative Work

- It will be difficult to appropriate sufficient or realistic amounts to projects that are not well planned and at an advanced stage of design. Dollars appropriated to such projects unless specifically intended to fund planning and design are likely to sit idle. This will be a challenge for both local and state-owned projects.
- The Legislature could consider prioritizing or restricting 2024 capital
  appropriations to complete funding for existing projects, including
  projects that have secured other funding but require some additional
  amount to proceed with construction, phased projects, and projects
  with previous state appropriations. Other options for prioritizing 2024
  appropriations might include emergency projects or critical
  infrastructure.
- The Legislature could consider developing cost indices that guide what the state will contribute toward project costs. Arizona uses such an approach for public school construction.
- The Legislature could consider adopting an earlier deadline for local capital outlay requests and using any increase in legislative staffing to implement basic vetting of requests. Such an approach could allow the Legislature to develop a funding mechanism for planning and design, to reserve major capital dollars for construction-ready projects, and to improve coordination of capital appropriations with other funding sources. Legislators could continue to maintain broad discretion over their appropriations.
- The Legislature could consider long-term strategies to stabilize annual revenues available for capital projects to increase the predictability of demand from the public sector.

#### **Debt Capacity and Long-Term Revenue Issues**

While recent general fund surpluses have allowed the Legislature to cash finance the capital outlay bill, the traditional source of funding for capital projects is severance tax bonds. The bonds are a form of debt that is repaid with revenues from severance taxes on oil, gas, and other minerals, which are deposited into the severance tax bonding fund. By law, total debt is limited to 86.2 percent of the lesser of current-year or prior-year bonding fund revenue. Capacity for long-term debt is based on estimates for 10 years of revenue, interest rates, and other factors.

Note: Low and high production estimates are based on CREG oil and gas scenarios.



The state's debt capacity has increased significantly over several years as a result of the oil boom, but as recently as 2017, revenues were insufficient to support any new capital appropriations. In the long-term, these revenues are expected to stagnate and then decline, with a steep decline forecast by the late 2030s under both baseline and high production scenarios.

The decline is likely to make it difficult for the state to both finance new capital projects and to maintain the investments it is making today. This challenge will weigh on the general fund as it becomes a replacement source for capital at a time when general fund revenues will already face headwinds from declining oil and gas production. To avoid this future fiscal strain on the state, additional long-term planning and preparation for the capital outlay program is needed.

Additionally, if fully utilized, current increases in capacity present a risk to the state's bond ratings due to the potential impact to debt ratios. The July 2023 long-term estimates showed debt ratios for New Mexico are expected to soar. By adhering to debt ratios in line with the national average, a state demonstrates prudent fiscal management, instills investor confidence, and reduces the risk of default from an excess of debt repayment per person.

Options for addressing these issues include tying debt capacity to debt ratios, which could stabilize funding available for capital projects, extend available capacity from severance tax revenues, and help secure the state's bond ratings, and exploring the creation of a capital reserve with unused bonding fund revenue or other sources.

#### **Earmark Funds**

Recent distributions to four earmark funds have grown far beyond expectations when most of the earmarks were originally enacted. The status of projects funded through the Water Trust Board (**Attachment A**), the Colonias Infrastructure Board (**Attachment B**), and the Tribal Infrastructure Fund (**Attachment C**) are summarized in the respective attachments.

#### **Authorized But Unissued Projects (Attachment D)**

Attachment D provides a list of projects authorized by the Legislature for which bonds have not yet been sold. Projects may be stalled due to lack of audit compliance or readiness to proceed. As of July 2023, a total of \$15.7 million for 71 projects was authorized but unissued.
