## Judiciary FY26 Budget Request

\$42,999.3 recurring

\$74,145.2 one-time

#### **Budget Request Highlights**

- **\$40 million** (one-time) to complete statewide implementation of For the Record (FTR) Speech to Text
- **\$25.2** million (one-time for 6 yrs) for statewide security needs
- **\$13.6** million for pay increases for lowest paid employees throughout the state
- **\$7.1** million for critical IT needs, including cybersecurity
- **\$3.3 million** for statewide pretrial services
- **\$2.2 million** for jury & witness program to pay for juror costs in all courts
- **\$2.7 million** for recurring funding for behavioral health programs
- **\$731,800** for magistrate courts and AOC facilities leases
- \$608,800 for interpreter costs
- \$285,000 for a statewide self-help center

## **Employee Compensation**

- 2,000 employees across the state
- Entry-level Judicial Branch employees
  - make 25% less than their counterparts in the Executive Branch\*
  - o qualify for means-tested public assistance
  - are below the MIT living wage in NM\*\*

## Statewide Security - \$25,200,000(6-year request)

Security threats have <u>increased by 60%</u> since FY23 and the level of violence is unprecedented.

In **Espanola**, the judge had to disarm a person who was overdosing.

In **Grants**, a man carrying an axe entered the courthouse announcing an intention to kill a judge.

In **Carrizozo**, an armed man entered the courthouse and demanded to be sworn in as sheriff.

In **Los Lunas**, a man with a history of making pipe bombs is currently on the run and fixated on the magistrate court.

In **Santa Fe**, an unknown person deposits balloons with heroin the day before custody arraignments at least once a month.

In **Clayton**, a person who was disturbed entered the courthouse, requiring the only employee in the courthouse to hide inside an abandoned safe while law enforcement surrounded the building and ultimately conducted a search before freeing the employee.

- County Sheriff
  - District Court pursuant to statute
  - o Magistrate Courts by contract
  - Rural LE agencies are facing critical staffing shortages
- Private security
  - By contract in some magistrate courts
  - Difficult to obtain at reasonable prices in rural communities
- Equipment
  - Lighting, Access Control, X-Ray deter crime but require personnel

### Statewide Security Request

- **\$25 million** 50 judicial facilities (roughly \$421,000/facility)
- **\$2 million** Santa Fe Magistrate Court
- **\$200,000** AutoClear x-ray scanners and magnetometers
  - One-time funding request over 6-year to upgrade security at all judicial facilities across the state
    - Procurement of equipment hardware, software and installation
    - Semi-centralization of services to quickly retrieve video footage, secure entry
    - Fire alarm system & detections upgrades
    - Intrusion system & detection
    - Duress alarms
    - Walk through metal detectors
    - AutoClear x-ray scanners

## Challenges


Judiciary's share of state general fund is shrinking.

## **AOC One-Time Appropriation Requests**

- **\$40,000,000** Courtroom modernization and Speech to

  Text FTR statewide upgrade project completion
- **\$25,200,000** Special for Statewide security needs (6-yr funding request)
- **\$430,000** Supplemental for Language Access increase in interpreter costs

## Administrative Support (P559) **\$3,672,600 Increase**

### Administrative Support (P559) Cont.

#### **Human Resources**

- ▶ 67 new hires in FY24 (216.5 total FTEs)
- 27 new hires in FY25 to date
- Since July 2024, 7 candidates have declined job offers due to salary
- ▶ 120.0 HR Project Manager request

#### Fiscal Services

- ▶ 88.0 for one additional Financial Specialist to properly manage appropriations
- Successfully rolled out matching funds for counties for district court construction and upgrades
- Added first new Fiscal employee in over 7 years in FY25 thanks to Legislative funding

1.0 FTE - administrative support to allow for specialized jury staff training statewide


FY24 Highlights


- ▶ **747** jury trials held
- ▶ **24,699** jurors were impaneled
- ► \$3,675,095 paid to jurors and witnesses
- ➤ Since Pre-Covid the cost of jurors has increased 29%
- ► From FY23 to FY24 juror costs increased an additional 10%

## Administrative Support (P559) Cont. Language Access - Interpreters

**\$430,000** for interpreter rate increases

\$178,800 for 2 FTE for interpreter scheduling & coordination





### Statewide Judiciary Automation (P560) Judicial Information Division (JID)

The Judicial Information Division provides the IT services for the New Mexico judicial branch:

- → Network design, connectivity, and support
- → Cybersecurity leadership, policies, services, and tools
- → Enterprise applications, including case management
- → Software development,
- → Computer and desktop maintenance and support,
- → Court data analysis and governance
- → Courtroom technology and other IT related services

### Statewide Judiciary Automation (P560) Judicial Information Division - \$7.4 million

#### \$6,144,500 - expansion and right sizing

- Cybersecurity tools and environment hardening
- Critical services funding shortfall for judicial internet connectivity, statewide software licenses for email and related functions, data backup infrastructure, text alerts for hearings, user authentication
- Statewide For the Record (FTR) annual licensing
- IT infrastructure upgrades and license cost increases
- Permanent funding for 8 existing positions

#### **\$920,000** - new FTE positions

Since 2014, JID added a significant number of services and applications without corresponding staff FTE positions to support this work

- 6 FTE to support security and expanded IT services
  - Network System Administrators (2 FTE)
  - Application support (2 FTE for e-filing, case management, public access)
  - o Data analysts (2 FTE)
- IT Recruiting has become increasingly difficult.

## Magistrate Court (P610) Court Operations Division - \$1.6 million

#### \$1,479,000

- Magistrate Court lease increases
- Technical service contract for security access control
- Complete TERM to PERM conversion for 12 filled FTE

#### **\$160,000** for 2 FTE

- Business Specialist for Security Team
- Project Manager for Facilities Team

#### FY24 Accomplishments

- 10,000 calls/month
- Lease renegotiation
- Court Operation Analysis Team

## Special Court Services (P620) Cont. Pretrial Services

- The AOC Electronic Monitoring (EMS) Unit\*:
  - o investigated over **245,000** alerts
  - 3,250 elevated investigatory responses resulting in 201 bench warrant requests
  - processed 13,277 release logs
     from jails in the state.
  - monitors over 215 defendants statewide each day.

#### \$1,277,900

- → Fully fund the EMS Unit and continue statewide, 24-hour monitoring of defendants ordered to GPS.
- → Currently funded through Special Appropriation that will be expended in FY25
- → Without additional recurring general funding the EMS Unit will be eliminated.

## Special Court Services (P620) Cont. Behavioral Health Programs

#### \$1,000,000

- ◆ Competency Diversion & AOT
   ◆ For participant treatment costs in the 1st, 3rd, 4th, and 12th judicial districts.
   ◆ Treatment regardless of insurance coverage

#### **\$662,200** for 4 new FTEs

- 2 statewide program managers4 local district court program managers

#### \$50,000

- Data tracking and management for Coordination of care
- Program evaluation

## Special Court Services (P620) Cont. Access to Justice & Court Appointed Attorneys

### \$45,000

 Contractor to assist with technical implementation of web-based selfhelp resources

### \$240,000

- 2 FTEs to:
  - 1) manage legal content
  - 2) coordinate live resources to assist with navigating court process or administrative questions regarding a live case

#### \$495,000

 To ensure representation in court-adjacent programming: Assisted Outpatient Treatment (AOT), civil commitment process, adult guardianships
