The Eleventh Judicial District is comprised of six court locations; three magistrate and three district courts, spread across two counties in the beautiful Four Corners region of northwest New Mexico. The following demographics reflect our diverse population:

McKinley County has a population of 72,902 with a median household income of \$40,108. 78% of the population is American Indian, 12% is Hispanic, and 10% is White. 45% of households speak a language other than English.

San Juan County has a population of 120,675 people with a median household income of \$50,734. The population is 37% White, non-Hispanic; 43% American Indian, and 20% Hispanic. 31% of households speak a language other than English.



COMMUNITY OUTREACH

BEHAVIORAL HEALTH INITIATIVES

The Eleventh Judicial District has collaborated with the Behavioral Health Services Department (BHSD) to pilot a competency clinic in the district. The partnership provides an Administrative Assistant who coordinates and schedules all competency evaluations for the district, as well as providing text and call reminders to defendants for their scheduled evaluations. The Administrative Assistant also coordinates transpiration services for defendants as needed.

The project has successfully coordinated evaluations that meet the time limits required by the Supreme Court. In addition, we have a specialized Pretrial Services caseload for defendants who are pending competency determination, which provides frequent check-ins, referrals for services, and coordination with case managers and family support.

We are further expanding this program by piloting the implementation of Pretrial Support Navigators, who will work closely with Pretrial defendants with behavioral health needs that could benefit from case management services.
