

Status of State Data Privacy Laws in 2024



Summary of Basic Rights by State

- There is a high degree of commonality among the state laws.
- The business community places a very high value on consistency across states.
- Most of the "standard" provisions in the CT/MN laws can be considered "settled"

Enhancements in MN HF2309

- Improved definition of precise geolocation
 - Latitude/Longitude accurate enough to identify a street address
- Reidentification of deidentified data by 3rd Parties Prohibited
- Explicit "Privacy by Design" requirement in annual assessments
 - Data minimization
 - Data retention
 - Data inventory
- Fair Credit Reporting Act protections extended to other "Profiling"
 - Right to view and correct data and have profiling rerun.
 - Right to an explanation of profiling process and results
 - Eliminates the need for separate AI "Automated Decision-making" Legislation

Heavily negotiated points

- Definition of Sale (Cash only vs Cash or other valuable consideration)
- Exclusions sought for financial services industry & non-profits
- Definition of Specific Geolocation Data
- Inclusion of "privacy by design" requirements in annual assessment
- Right to cure (Temporary)
- Organization size threshold (Small Business Exemption)
- Private Right of Action (no state has granted it, yet.)

Keys to Success

- Minimize deviations from the WPA template (CT Version)
 - Point to Commonalities with previously passed bills
 - You can engage in selective cherry-picking
- Communicate Proactively with Stakeholders
- Vet your bill with trusted stakeholders from all perspectives
