



# Teacher Licensure Advancement

There are two pathways for New Mexico Teachers to earn licensure advancement between levels — from Level 1 to 2 and from Level 2 to Level 3.

## NATIONAL BOARD CERTIFICATION

Advancing from a Level 2 to Level 3 license via NBCT does not require a master's degree.

## Advancement Program Level (APL) MICRO-CREDENTIALS

Advancing from a Level 2 to Level 3 license via APL Micro-Credentials requires a master's degree.

# Micro-Credentials — What and Why?

A micro-credential is a competency-based process that is made up of several **small, “stacked” courses**, each focused on a discrete skill or area.

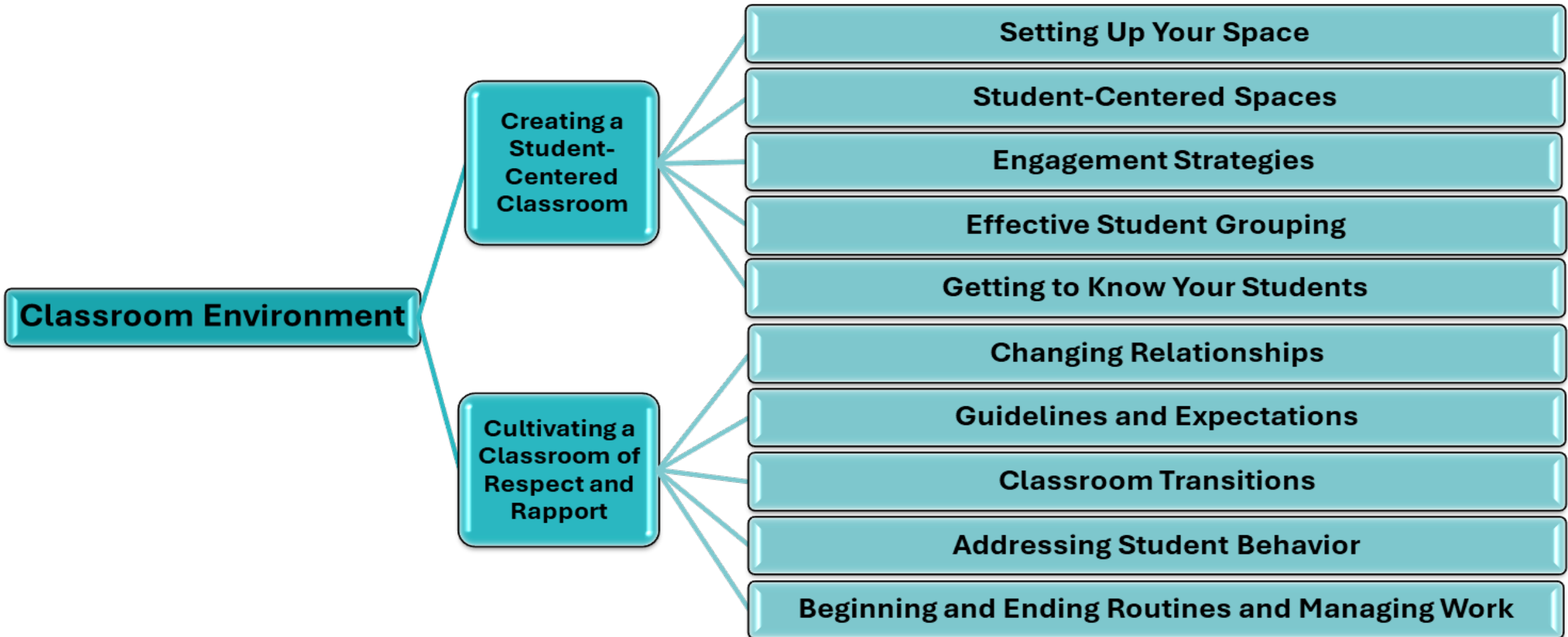
**Enhancing Teacher Skill Sets.** Micro-credentials offer a flexible approach to professional development, allowing teachers to acquire new skills tailored to their needs.

**Enriching Teaching Strategies Toolbox.** Teachers gain access to diverse instructional techniques, assessment methods, and classroom management strategies.

**Affirming Prior Learning.** Micro-credentials recognize and validate teachers’ existing knowledge and experiences beyond their initial teacher preparation programs.

**Embracing the Future.** We are changing the way we teach in New Mexico, aligning and providing strategies to grow high-quality educators and educational leaders.

# Mastery Component Assignments

- Every micro-credential has mastery component assignments, consisting of performance tasks.
- The performance tasks are designed to provide an opportunity for the educator to demonstrate understanding of key concepts presented in the micro-credential.
- The mastery component performance tasks are at the end of every micro-credential and are aligned with the Elevate NM Teacher Evaluation domains.
- Educators may resubmit assignments within 3–5 days of receiving the initial grade and comment posted in the gradebook.

# Components and Completion of a Micro-Credential

## All micro-credentials include:

- Mastery component — 85% or higher to pass
- Researched-based materials, videos, and resources
- [Examples of Resources and Activities](#)
- Assignments related to classroom practice and aligned with the Elevate NM Teacher Evaluation Domains
- Articles and Videos
- Website review
- Reflections
- Quizzes
- Slide decks

**Successful completion of a micro-credential** makes an educator eligible to progress to the next micro-credential.

- Educators are required to complete a survey at the end of each micro-credential.
- Once submitted, the subsequent module offers an enrollment link for the next micro-credential.

# Overview: Level I Advancement Program

## **Five micro-credentials are required**

- Classroom Environment
- Assessment Literacy
- Multi-layered System of Supports
- Culturally and Linguistically Relevant Instruction
- Family Engagement

## **Must pass the mastery component for each micro-credential (85% or higher)**

A facilitator is provided for each micro-credential to:

- Mentor and guide the educator through the content.
- Review and provide feedback on assignments based on common rubrics.
- Score mastery components based on common rubrics.

# Overview: Level II Advancement Program

## Four Micro-Credentials are required

- Social Emotional Learning
- New Mexico Education Acts
- Two electives will be chosen by the educator from a library of micro-credentials
  - Restorative Practices
  - Vocabulary Development through Cognates
  - Engaging Students in Learning
  - Mentoring/Coaching Teachers
  - Trauma Informed Classroom (Starting July 8, 2024)
  - Building and Sustaining Collaborative and Inclusive Teams (Starting October 1, 2024)

## Must pass the mastery component for each micro-credential (85% or higher)

A reviewer is provided for each micro-credential to:

- Provide feedback to the educator.
- Score mastery component performance tasks based on common rubrics.

# Benefits of APL Micro-Credentials

## **More flexibility with enrollment**

- Can skip a quarter and resume where left off

## **Reduction in financial burden**

- \$60.00 per micro-credential
- No cost for re-submission of mastery components if submitted before the end of the micro-credential

## **Professional learning and growth**

- APL micro-credentials provide growth-oriented professional learning which educators can immediately implement in their instruction.
- Facilitators, who are educators and content area experts, support educators as they participate in each micro-credential.
- Educators can use their experience and learning in the micro-credentials as part of their PDP in Elevate NM (teacher evaluation system).

# The Team Behind the Micro-Credentials Program

**Licensure Advancement Coordinator (LAC).** Responsible for leading and implementing the APL Micro-Credentials Pathway for Teacher Licensure Advancement. The LAC's primary responsibility is to manage the implementation of the APL Micro-Credentials Pathway by establishing supportive structures and systems.

**APL Micro-Credential Liaison.** Supports APL implementation, maintenance of quality, and rigor of micro-credential content. Supports 10 Lead Facilitators and approximately 120 Facilitators and serves as the liaison between the LAC, facilitators, and educators.

**Lead Facilitators.** Support facilitators (up to 40 per micro-credential) within the assigned APL I-II Micro-Credentials and will serve as the contact between the facilitators and the PED Licensure Advancement Coordinator.

**All Facilitators and Reviewers.** Participate in APL training on grading and cognitive coaching. Provide quality feedback via a Canvas course.

# Any Teacher with a NM Teacher License is Eligible

- Level 1 teachers may begin participating in the APLI-II Micro-Credentials Pathway as early as their first year of teaching. They can begin their enrollment by using this link:


