# Dataset info/highlights

- •AOC-sourced cases/charges dataset covering 2.4m+ records, from 2017 to June 2024
  - AOC-sourced data was provided with one sheet for each year of data; due to number of records per sheet, data was collated in a database and then analyzed
- •Following analysis removed Adult Motor Vehicle Offense cases, Juvenilerelated cases, Parking/Traffic cases, and Youth Offender cases



## Analysis of AOC Data

### Since 2017, 16,045 Charges Dismissed due to Incompetency

- Across 3,217 defendants
- 5,359 Felony Charges Dismissed; felony charges (n≥100) include:
  - 684 Battery upon a Peace Officer
  - 648 Possession of a Controlled Substance (various)
  - 390 Aggravated Assault (Deadly Weapon)
  - 353 Criminal Damage to Property (Over \$1000)
  - 262 Breaking & Entering
  - 226 Burglary of a Vehicle
  - 212 Battery upon a Health Care Worker
  - 140 Residential Burglary
  - 139 Child/Minor related charges
    - Includes child abuse, criminal sexual contact/penetration, and other associated charges
  - 135 Aggravated Assault/Battery (Household Member)
  - 106 Unlawful Taking of Motor Vehicle (1st Offense)
  - 100 Aggravated Battery (Deadly Weapon)




