Senate Bill 423 NMFA Operating Capital



- SB 423 NMFA Operating Capital Bill (2023 Session, Sen. Nancy Rodriguez) expanded the use of three programs to including working capital.
 - Primary Care Capital Fund
 - Behavioral Health Capital Fund
 - Child Care Revolving Loan Fund
- These changes were sought in response to community service providers needing both working capital in addition to traditional capital projects (building, equipment, etc)
- With the critical changes provided by the enactment of SB 423, NMFA is now prepared to offer programming that fully meets the needs of these critical care providers
- NMFA just needs funding.
- Requesting \$25 million each for the Behavioral Health Capital Fund and the Primary Care Capital Fund and \$10 million for the Child Care Revolving Loan Fund. To date, only the Primary Care Capital Fund has ever received a general fund appropriation with \$9 million appropriated to the Fund since 1995 and \$9.7 million reverted for solvency.


Access to Service



• Primary Care and Behavioral Health sites are typically the largest employer in many rural and frontier areas throughout the state

- Provide services to residents that are uninsured, insured with Medicaid and Private Insured
- Most patients' income is 200% below the Federal Poverty Levels
- Recent access models have been success in a one stop shop model

Types of Services



- 1,400,000 services are rendered to 350,000 patients in every county in New Mexico
- 80% of the services are in rural and frontier designated areas
- Many of these centers also house community & social services for:
 - WIC
 - Food Stamps
 - Food Banks
