


#### Santa Fe County Health Priorities

  - Access to ongoing treatment services

### Behavioral Health (AD and MB) Crisis Services

- Mobile Crisis Response Team-CSD partners with Presbyterian Medical Services
  - Funded since 2014
  - 24 hour response
  - Follow up navigation
  - 2016 Data
  - 266 MCRT dispatches (200 from Law Enforcement)
  - 421 Follow up linkages
  - 104 Emergency room diversions



Behavioral Health Services Crisis Center Model (RO)

• **GOAL**: To provide a safe and secure place for Santa Fe County adults with behavioral health issues (mental illnesses and/or addictions) and their families and caregivers to find information and receive assistance in times of crisis, and to provide linkage with needed community services.



## What Are the Primary Goals? (RO)

- To reduce unnecessary admission to hospital emergency departments
- To prevent unnecessary detainment of individuals in criminal facilities
- To provide immediate crisis management and deescalation support
- To ensure individuals are connected with ongoing clinical and social support, including navigation, to prevent further crisis



### Who Will It Serve? (RO)

- Adults 18 years old and their families with behavioral health needs who are experiencing a crisis, including mental health and substance abuse
- We estimate approximately 2,500 visits per year


