
NNMC's efforts with High Schools in terms of CTE programs

Northern New Mexico Branch Community College (NNMCC) District Mill Levy (formed by the school districts of Espanola, Pojoaque, Jemez Mountain, Chama, and Mesa Vista, see map below) currently supports efforts for CTE dual credit opportunities of Branch Community College District members for the community college technical trade programs and is open to non-district members. Technical Trade faculty and staff collaborate with partner districts by providing instruction at the NNMC campuses and directly on-site at district member facilities. Mill Levy funds are directed through the college administration with the fiscal accountability of assuring all elements of student learning are met, including the support systems such as advisement,

registration, teaching, supplies, equipment, mentoring, tutoring, counseling, and accessibility resources.

Dual credit secondary schools also have funding for CTE, such as the CARL Perkins fund and the State of NM Next Generation funds. Determining how those CTE awards are spent is entirely up to the secondary partners. In one example, collaboration is active between NNMCC and Espanola Valley School District, where the district utilizes their Carl Perkins grant for NNMCC dual credit offerings in Trades. At the same time, the college uses Mill Levy funds and a portion of its Carl Perkins allocation to deliver this instruction. We also collaborate with the Espanola School district on health and computer science dual credit.

The Mill Levy in place for a specific purpose, program, or pathway may require voter approval to modify the use of funds. The Northern New Mexico College Branch Community College District Mill Levy has CTE and dual credit as the leading mission of the Levy. NNMC updates a Master Dual Credit Course Schedule yearly.
