
Fathers Building Futures

Fathers Building Futures

FATHERS BUILDING FUTURES FACT SHEET

- \$40,000 annual cost per inmate to arrest, prosecute, house, rehabilitate and supervise; 96% of them will return to their New Mexico communities.
- 52% return to prison within 5 years; of that number, 41% return once, 28% return twice, 16% return 3 times and 14% will return 4 or more times.
- Crimes committed by these released prisoners as New Mexico citizens totals approximately \$40,000,000/year in victimization costs.
- Resulting in New Mexico taxpayers spending an estimated \$360,000,000 over 15 years.

Since Fathers Building Futures started in 2012:

- 350+ fathers have participated in our program with a success rate of 75.6% of these men remaining out of
 prison, with jobs and supporting their homes.
- Over \$66,000 was paid in child support, with over 630 children having established a relationship with their father, or living with their father.
- 50% filed a tax return; 22% of them established a bank account.
- The New Mexico Sentencing Commission in its December 2015 report, cited Fathers Building Futures'
 recidivism rate at 24.4% (dropping to 11.8% when parole/probation violations are excluded); compared to
 New Mexico's rate of 47.3% rate.

Moving forward:

- Initiated by a 2011 federal grant, we have received public recognition and have become a national model. As of the grant's 2015 conclusion, our innovative outcomes are being evaluated by the New Mexico Sentencing Commission and nationally by the Urban Institute.
- For greater impact, we are separating from our parent agency (PB&J Family Services), and have established nonprofit status with a **Board of Directors and a Business Advisory Team** committed to fostering Fathers Building Futures' expansion.
- Our four business units (auto detailing; mobile power washing; CDL certification/freight delivery; custom woodworking) provides full-time employment to 8 parents, with job training and placement assistance for 30 others, with a goal to become fully-sustaining in 5 years.
- One-third of this year's revenues come from our four business units and the rest in the form of donations from persons who believe in our work to turn CONS INTO PROS.

In 2012, the Pew-MacArthur initiative studying New Mexico prison incarceration costs yielded these two key results:

- Reducing recidivism by merely 10% through investment in evidence-based programs like Fathers Building
 Futures could reduce costs by \$8.3 million yearly.
- Investment in evidence-based programs focused on reducing recidivism could yield returns as much at \$25 for each \$1 invested.
