
### Overview

# Crime Rates in Albuquerque and the US (1985-2017)




## Albuquerque has experienced a significant increase in crime since 2010

**Violent Crime Rate** 

- Property crime started increasing in 2010
- Violent crime started increasing in 2013

# A note about benchmarking and rankings...

#### From the FBI:

 Many entities—news media, tourism agencies, and other groups with an interest in crime in our Nation use figures from the Uniform Crime Reporting (UCR) Program to compile rankings of cities and counties. These rankings, however, are merely a quick choice made by the data user; they provide no insight into the many variables that mold the crime in a particular town, city, county, state, region, or other jurisdiction. Consequently, these rankings lead to simplistic and/or incomplete analyses that often create misleading perceptions adversely affecting cities and counties, along with their residents.



#### Some areas of the state have <u>higher crime rates</u> than ABQ


#### Total crime rate per 100,000




#### The ABQ crime rate is higher than average of other NM cities

## Crime Trends 2014-2016

- When compared to crime trends in the 30 largest cities in the US, Albuquerque is ranked:
  - 1<sup>st</sup> in increases in all crime (26% increase)
  - 4<sup>th</sup> in increase in violent crime (26% increase)
  - 1<sup>st</sup> in increase for property crime (26% increase)
  - 1<sup>st</sup> in increase for murder (102% increase)
- On average over the same period, crime decreased in the 30 largest cities by 2.8%



# Generally speaking, what works to deter crime?

- According to National Institute of Justice
  - The <u>swiftness</u> and <u>certainty</u> of being caught is a vastly more powerful deterrent than the punishment
  - Sending an individual convicted of a crime to prison isn't a very effective way to deter future crime
  - Police deter crime by increasing the perception that criminals will be caught and punished
  - Increasing the severity of punishment does little to deter crime
  - There is no proof that the death penalty deters criminals



Note: Research indicates not all criminal acts can be influenced by deterrence. The most significant effects appear to be on minor crimes (Dolling, Entorf, Hermann, & Rupp (2009))

### More on what works...

- There is a significant amount of research on the impact of program and policies on crime avoidance, recidivism, and return on investment.
- LFC has been working with the Pew MacArthur Results First Initiative for 7 years to perform such analysis.
- LFC plans to incorporate these tools into the review.





## Case Management Order (CMO) implementation correlated with a spike in case dispositions





- Traditional factors including:
  - Economic conditions
  - Substance Abuse
  - Gang activity
- System related issues including:
  - Diversion and Treatment (mostly dealing with substance use)
  - Theory of "revolving door"
  - Police practices, arrests and rearrests
  - Benchmarking funding and staffing levels
  - Pretrial services/Court system
  - Sentencing and incarceration
  - Reentry from Jail and Prison
