# GENERAL OBLIGATION BOND BILL (GOB)

Capital improvements and acquisitions for senior centers, libraries and higher education are included in the GOB

Biennial in even-numbered years

State agency recommendations

# CAPITAL PROJECT REAUTHORIZATIONS

Capital projects authorized or appropriated in previous years may be reauthorized to extend the time of expenditure, change the administering agency or change the scope of the project.

Requests must be signed by a legislator and submitted to the LCS by 3:00 p.m. on Sunday, January 28, 2024.

Tentatively, a report showing all the requests to be included in the bill will be circulated on February 8, 2024.
