

Transportation Infrastructure Revenue Subcommittee 2023 Interim Summary

The Transportation Infrastructure Revenue Subcommittee met six times in the 2023 interim, holding a meeting in each of the six transportation districts. At each meeting, the subcommittee received updates by a transportation district's engineer on the district's completed, current and upcoming transportation projects, as well as the district's needs.

The subcommittee began the interim in Santa Fe by reviewing the Department of Transportation's financial situation, including its funds, past and present budgets, staffing levels and expenditures. The subcommittee also examined the department's responsibilities and priorities, including the Statewide Transportation Improvement Program and the Transportation Asset Management Plan.

The July meeting in Hobbs focused on road and trucking safety, with a tour of Hobbs' and Jal's most dangerous roads. In addition, the subcommittee received presentations on the incorporation of broadband into roads and recent developments in southern New Mexico, including a fracking sand conveyor belt and the progress of a developing interstate highway corridor.

At its August meeting in Las Vegas, the subcommittee examined the state's escalating issue of traffic-related crashes and discussed potential safety strategies. The subcommittee wrestled with two other pressing issues: increasing funding for transportation projects, especially through the use of alternative revenue sources, and the rising costs of road work.

The September and October meetings in Albuquerque and Truth or Consequences featured topics on the future of transportation, with presentations on self-healing roads, more sustainable and cost-effective highway construction, multimodal transportation options, electric vehicles and the charging grid, roadable aircraft and aviation fuel. The sixth and final meeting was held in Gallup, where the subcommittee witnessed firsthand Gallup's efforts to use transportation to drive economic development, was updated on the state-level administration of the federal Bipartisan Infrastructure Law and considered and endorsed four pieces of legislation.

Work Plan

The New Mexico Legislative Council created the Transportation Infrastructure Revenue Subcommittee on May 1, 2023 to develop recommendations to meet the needs of New Mexico's businesses and residents for transportation and infrastructure and to identify current and new sources of revenue.

During the 2023 interim, the Transportation Infrastructure Revenue Subcommittee will review and discuss the following topics, as time permits:

A. the Department of Transportation (DOT):

- 1. overview of divisions, budgets, projects, the Transportation Asset Management Plan and Section 9 funding;
- 2. performance data, project status report and capital outlay report;
- 3. project prioritization;
- 4. the Statewide Transportation Improvement Program;
- 5. escalating costs; and
- 6. engineer reports from each of the six transportation districts on projects, needs, prioritization and opportunities; the impact of the governor's maintenance budget; and over/under of each project;

- B. fuel taxes, excise taxes and alternative revenue sources;
- C. electric vehicles, the electric charging grid and related infrastructure;
- D. broadband infrastructure, DOT rights-of-way and "smart" roads;
- E. fire recovery, flood recovery and drainage;
- F. commercial trucking and the Permian Basin;
- G. the future of transportation and proposed legislative changes relative to:
 - 1. commercial space;
 - 2. drones;
 - 3. autonomous vehicles;
 - 4. unleaded aviation fuel;
 - 5. roadable aircraft; and
 - 6. front end license plates and registration stickers;
- H. multimodal transportation and evolutionary infrastructure planning, including:
 - 1. intelligent roadways and improving traffic design;
 - 2. methods to increase safety and reduce accidents;
 - 3. a review of data on driver impairment and substance abuse treatment requirements for a commercial driver's license holder;
 - 4. new construction materials; and
 - 5. protected bicycle lanes;
- I. public-private partnerships and advanced infrastructure partnerships;
- J. the federal Infrastructure Investment and Jobs Act and government-to-government relations;
- K. the "Ports-to-Plains" trade corridor;

- L. ports of entry and economic development initiatives;
- M. National Conference of State Legislatures best practices for transportation and infrastructure legislation;
- N. the consideration of legislation for endorsement; and
- O. the establishment of the Transportation Infrastructure Revenue Subcommittee as a committee.



Subsection D of this section, money in the transportation trust fund may be:

expended in the event that general fund (1) balances, including all authorized revenues and transfers to the general fund and balances in the general fund operating reserve, the appropriation contingency fund, the tobacco settlement permanent fund, the state-support reserve fund and the tax stabilization reserve, will not meet the level of appropriations authorized from the general fund for a fiscal year. In that event, to avoid an unconstitutional deficit, the legislature may appropriate from the transportation trust fund to the general fund only the amount necessary to meet general fund appropriations for that fiscal year and only if the legislature has authorized transfers from the appropriation contingency fund, the general fund operating reserve, the tax stabilization reserve and the tobacco settlement permanent fund that exhaust those fund balances; or

date of appointment until December 31, 2024. The task force shall meet at the call of a co-chair or at the request of one-third of its membership, and as necessary to carry out its duties, but not less than once and no more than three times per month. A majority of the members constitutes a quorum for the transaction of business, and the support of a majority of the members is required for adoption of any action.

- C. The intrastate airline task force shall study and provide recommendations on establishing an intrastate airline transportation system to provide regular and consistent flights between the cities of Albuquerque, Las Cruces, Hobbs, Clovis and Gallup, including:
- (1) the projected demand over the next fifteen years, considering population density and trends, existing transportation options and business and tourism activity;
- (2) the necessary and optimal routes, flight frequency, number of aircraft and types of aircraft to meet projected demand;
- (3) the projected profitability of an airline that would service the flights;
- (4) the strengths, weaknesses, opportunities and benefits of the airline being privately owned, publicly owned or operated via a public-private partnership;
- (5) necessary new infrastructure and modifications to existing infrastructure;

- (6) the costs, revenue and benefits to the state for both a privately and publicly owned airline;
- federal law regulations with which an (7) intrastate airline transportation system would need to comply; and
- any other actions required by the state to facilitate the success of the intrastate airline transportation system, including policy or legislative changes and potential incentives to attract a private business to operate it.
- The intrastate airline task force shall by December 1, 2024 report its findings, recommendations and any proposed legislation to the legislative finance committee, the interim committee that studies economic and rural development and policy, the interim committee that studies transportation and any other appropriate legislative interim committees.
- Ε. The intrastate airline task force may contract with economists, consultants and other experts to assist the task force in carrying out the provisions of this section.
- Members of the intrastate airline task force are entitled to receive per diem and mileage as provided in the Per Diem and Mileage Act and shall receive no other compensation, perquisite or allowance.
- The economic development department shall provide the necessary staff and administrative support to the intrastate airline task force.

SECTION 2. APPROPRIATION.--Five hundred thousand dollars (\$500,000) is appropriated from the general fund to the economic development department for expenditure in fiscal years 2024 and 2025 for the purposes of the intrastate airline task force. Any unexpended or unencumbered balance remaining at the end of fiscal year 2025 shall revert to the general fund.
