The Plaintiffs-Appellants hereby move the Court to supplement the Record Proper with the documents included in their Appendix to the Plaintiffs-Appellants' Brief-in-Chief: the transcript of the bench trial in this case, and the transcript of the deposition of Justice Edward L. Chávez. As grounds for this Motion, the Plaintiffs-Appellants state as follows:

1. Justice Chávez was the first witness deposed in this case and was a neutral witness (Chairman of the Citizens Redistricting Committee) who testified to largely undisputed facts that might nonetheless prove useful to the Court.

2. The Plaintiffs-Appellants and Defendants-Appellees agreed, near the end of the bench trial, to jointly procure and pay for transcripts of the trial; those transcripts are the ones in the Appendix.

3. These transcripts were cited in the post-trial briefing to the Court and submitted to the Court via email but were not placed formally in the record at that time.

4. The Defendants-Appellees were contacted for their position, and they do not oppose the requested supplementation.

The Brief-in-Chief and the Appendix thereto were both filed the evening of Saturday, October 28, 2023. Having earlier obtained the consent of the Defendants-Appellees to the supplementation, the Brief-in-Chief does cite the Appendix (including all three transcripts contained therein), which is paginated separately from the Record Proper.
