"(2) "health care facility" means a hospital, outpatient facility, diagnostic and treatment center, rehabilitation center, free-standing hospice or other similar facility at which medical care is provided;".

13. Renumber the succeeding paragraphs accordingly.

14. On page 3, line 14, after the comma insert "excluding elective or cosmetic surgery,".

15. On page 3, line 15, before the semicolon, insert "or in a health care facility".

16. On page 3, line 25, after "year" strike the remainder of the line, and on page 4, strike lines 1 and 2 and insert in lieu thereof a semicolon.

17. On page 5, between lines 1 and 2, insert the following new section:

"Section 3. CONTINGENT EFFECTIVE DATE.--The provisions of this act shall not become effective unless Senate Bill 33 or similar bill of the second special session of the fortyfourth legislature is enacted into law and the General Appropriation Act of 2000 passed by the second special session of the forty-fourth legislature and enacted into law includes an appropriation of four million nine hundred seventy-five thousand dollars (\$4,975,000) for the sole purpose of implementing an amendment to the state medicaid plan making eligible an individual who is the parent of a child under nineteen years of age who resides with that parent and whose family income does not exceed sixty percent of the federal poverty guidelines.".,
