AN ACT

**MAKING AN APPROPRIATION TO THE STATE DEPARTMENT OF PUBLIC
EDUCATION FOR THE PURPOSE OF BUILDING NECESSARY FULL-DAY
KINDERGARTEN CLASSROOMS THROUGHOUT THE STATE.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

**A. Fifteen million three hundred fifty-four
thousand dollars (\$15,354,000) is appropriated from the
general fund to the state department of public education for
expenditure in fiscal year 2002 to plan, design and construct
full-day kindergarten classrooms throughout the state. The
money shall be apportioned by the state department of public
education in the following amounts to the following school
districts for the following schools:**

9 B. One million four hundred thirty-two thousand
10 dollars (\$1,432,000) is appropriated from the general fund to
11 the state department of public education for expenditure in
12 fiscal year 2002 to plan, design and construct school
13 buildings in the Hobbs municipal school district that will
14 make other classroom space available for full-day kindergarten
15 classrooms in that school district.

16 C. Any unexpended or unencumbered balance
17 remaining from any of the appropriations in this section at
18 the end of fiscal year 2002 shall revert to the general fund.

19 Section 2. EFFECTIVE DATE. -- The effective date of the
20 provisions of this act is July 1, 2001.
