AN ACT

RELATING TO EDUCATION; ELIMINATING CERTAIN GRADUATION
REQUIREMENTS IN THE PUBLIC SCHOOL CODE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 22-2-8.4 NMSA 1978 (being Laws 1986,
Chapter 33, Section 5, as amended) is amended to read:

"22-2-8.4. GRADUATION REQUIREMENTS. --

A. At the end of the eighth grade or during the
ninth grade, each student shall prepare an individual program
of study for grades nine through twelve. The program of study
shall be signed by a student's parent or guardian.

B. [~~Beginning with students entering the ninth
grade in the 1986-87 school year~~] Successful completion of a
minimum of twenty-three units shall be required for
graduation. These units shall be as follows:

- 1 (1) four units in English, with major
2 emphasis on grammar and literature;
- 3 (2) three units in mathematics;
- 4 (3) two units in science, one of which shall
5 have a laboratory component;
- 6 (4) three units in social science, which
7 shall include United States history and geography, world
8 history and geography, and government and economics;
- 9 (5) one unit in physical fitness;
- 10 (6) one unit in communication skills, with
11 major emphasis on writing and speaking, which may include a
12 language other than English; and
- 13 (7) nine elective units. Only the following
14 elective units shall be counted toward meeting the
15 requirements for graduation: fine arts, [~~i.e.~~] including
16 music, band, chorus and art; [~~practical arts~~] physical
17 education; languages other than English; speech; drama;
18 vocational education; mathematics; science; English;
19 [~~R.O.T.C.~~] reserve officers' training corps; social science;
20 computer science; health education; American sign language;
21 and other electives approved by the state board.

22 With the approval of the local school board,
23 participation on an athletic team or in an athletic sport
24 during the school day may count toward fulfillment of the
25 physical education required unit.

11 constitution of New Mexico. If a student exits from the
12 school system at the end of grade twelve without having passed
13 a state competency examination, he shall receive an
14 appropriate state certificate indicating the number of credits
15 earned and the grade completed. If within five years after a
16 student exits from the school system he takes and passes the
17 state competency examination, he may receive a high school
18 diploma.

20 to provide for administrative interpretations to clarify
21 curricular and testing provisions of the Public School
22 Code. "
