AN ACT

RELATING TO THE REDISTRICTING OF THE HOUSE OF REPRESENTATIVES; ESTABLISHING REPRESENTATIVE DISTRICTS FOUR THROUGH SIX, NINE, SIXTY-FIVE AND SIXTY-NINE; REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 2-7C-11 NMSA 1978 (being Laws 1991 (1st S.S.), Chapter 2, Section 11) is repealed and a new Section 2-7C-11 NMSA 1978 is enacted to read:

"2-7C-11. [NEW MATERIAL] REPRESENTATIVE DISTRICT FOUR. -Representative district four is composed of San Juan county
precincts 2 through 4, 8 through 14, 18, 57, 81 and 82."

Section 2. Section 2-7C-12 NMSA 1978 (being Laws 1991 (1st S.S.), Chapter 2, Section 12) is repealed and a new Section 2-7C-12 NMSA 1978 is enacted to read:
