Precinct designations and boundaries used in the [1991] 2001 congressional redistricting are those precinct designations and boundaries established pursuant to the Precinct Boundary Adjustment Act and revised and approved pursuant to that act by the secretary of state as of [August 16, 1991] August 31, 2001.

B. [The boards] <u>A board</u> of county commissioners shall not create any precinct that lies in more than one congressional district, [nor] <u>and</u> shall [the boards of county .138905.1 - 3 -
