Section 2. A new section of the Election Code is enacted to read:

"[NEW MATERIAL] CANCELLATION OF REGISTRATION-DETERMINATION OF NONCITIZENSHIP. --

A. For the purposes of cancellation of registration, the noncitizenship of a voter shall be ascertained by comparison of registration records with the certification of alien status by the federal immigration and naturalization service.

- B. When, in proceedings held pursuant to law, a court of competent jurisdiction or the federal immigration and naturalization service determines that an individual is not a citizen of the United States, certification by the court or the federal immigration and naturalization service of that fact may be filed by a citizen with the county clerk of the county wherein the individual is registered.
- C. The certification of noncitizen status shall include the following information about the individual:
 - (1) name;
 - (2) age;
 - (3) sex;
 - (4) marital status;
 - (5) birth place;
 - (6) birth date;
