AN ACT

**RELATING TO EDUCATION; CREATING THE PUBLIC SCHOOL CODE REVIEW
TASK FORCE; REPEALING THE PUBLIC SCHOOL CODE AND OTHER
SECTIONS OF THE NMSA 1978; MAKING AN APPROPRIATION.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**Section 1. TEMPORARY PROVISION--PUBLIC SCHOOL CODE
REVIEW TASK FORCE CREATED. --**

**A. The "Public School Code review task force" is
created, composed of sixteen members appointed as follows:**

**(1) three members, including two principals
and one teacher from New Mexico public schools, appointed by
the speaker of the house of representatives;**

**(2) two members, including one principal and
one teacher from New Mexico public schools, appointed by the
minority leader of the house of representatives;**

1 (3) three members, including two principals
2 and one teacher from New Mexico public schools, appointed by
3 the president pro tempore of the senate;

4 (4) two members, including one principal and
5 one teacher from New Mexico public schools, appointed by the
6 minority leader of the senate;

7 (5) one member of the governor's staff
8 appointed by the governor;

9 (6) one member of the business community, who
10 is not employed in education services, appointed by the
11 governor;

12 (7) one school parent, who is not employed in
13 education services, appointed by the governor;

14 (8) two school district superintendents
15 appointed by the state superintendents association; and

16 (9) one member appointed by the state board
17 of education.

18 B. A vacancy on the task force shall be filled by
19 appointment and in the same manner as the vacant seat was
20 originally filled. All members of the task force shall be
21 appointed by July 31, 2002 and shall be appointed so as to
22 represent the geographic and cultural diversity of the state.

23 C. The state department of public education shall
24 staff the task force.

25 D. The members of the task force may receive per

1 diem and mileage as provided in the Per Diem and Mileage Act,
2 but shall receive no other compensation, perquisite or
3 allowance.

4 E. The task force shall function from the date of
5 its appointment until December 31, 2003.

6 F. The task force shall initially hold an
7 organizational meeting to select a chairman and to develop a
8 work plan. Thereafter, the task force shall meet as necessary
9 to carry out its duties as provided in this section.

10 G. The task force shall conduct a review of the
11 Public School Code and state board of education rules
12 governing primary and secondary education in New Mexico to
13 identify those statutes and rules that unnecessarily burden
14 administrators and teachers at the school site, and that
15 prevent administrators and teachers at the school site from
16 effectively performing their roles as instructional leaders
17 and educators.

18 H. The task force shall present its findings and
19 recommendations for an efficient and effective Public School
20 Code no later than December 31, 2003 to the state board of
21 education, the governor, the legislative education study
22 committee and the legislature for replacement of the existing
23 Public School Code.

24 Section 2. APPROPRIATION.--Twenty thousand dollars
25 (\$20,000) is appropriated from the general fund to the state

1 department of public education for expenditure in fiscal years
2 2003 and 2004 to provide per diem and mileage for the members
3 of the Public School Code review task force. Any unexpended
4 or unencumbered balance remaining at the end of fiscal year
5 2004 shall revert to the general fund.
