| 16 | Section 1. APPROPRIATION |
| 17 | A. Four million two hundred fifty-two thousand |

B. Any unexpended or unencumbered balance remaining at the end of fiscal year 2006 shall revert to the general fund.

Section 2. APPROPRIATION. --

A. Two million five hundred forty-three thousand one hundred dollars (\$2,543,100) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal year 2003 for the following purposes in the following amounts:

- (1) two million forty-three thousand one hundred dollars (\$2,043,100) to provide for increased operational costs; and
- (2) five hundred thousand dollars (\$500,000) as a base adjustment to provide for operational costs at Carrie Tingley crippled children's hospital.
- B. Any unexpended or unencumbered balance remaining at the end of fiscal year 2003 shall revert to the general fund.
