16	Section 1. Section 40-1-11 NMSA 1978 (being Laws 1957,

19	Before [any] <u>a</u> county clerk issues [any] <u>a</u> marriage license, [each
20	applicant for a marriage license shall file with the county clerk
21	a certificate from a physician licensed to practice medicine,
22	which certificate shall state that the applicant has had those
23	tests and examinations as required by regulation of the health and
24	environment department. Such tests and examinations shall be made
25	not more than thirty days prior to the date of application for

The certificate shall state that medical evaluation 2 or that treatment, as indicated, has been made such that there is no bar to marriage, as specified by the regulations of the 3 4 of health and environment department. B. The certificate of the physician shall be on a 5 form to be provided and distributed by the health services 6 7 division to all officers authorized to issue marriage licenses and to all physicians within the state. 8 9 C. The secretary of health and environment shall 10 make rules and regulations and employ personnel necessary to 11 effectuate the purposes of Sections 40-1-11 through 40-1-13 12 NMSA 1978. If regulations require a laboratory test, it shall 13 be done in a laboratory approved by the secretary of health 14 and envi ronment. 15 D. A county clerk shall accept, in lieu of the 16 physician's certificate, a certificate from any other state 17 having premarital laws, if issued within the time limits 18 prescribed in Subsection A of this section and if such laws 19 meet the regulations of the secretary of health and 20 envi ronment. 21 E_{-}] the county clerk shall receive a fee of 22 [twenty-five dollars (\$25.00)] forty dollars (\$40.00) for 23 issuing, acknowledging and recording [a] the marriage license 24 and marriage certificate.
