AN ACT

RELATING TO THE LEGISLATURE; REQUIRING ALL REPORTS TO THE
LEGISLATURE, OTHER THAN PROPOSED LEGISLATION, TO BE THREE
PAGES OR LESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 2-3-14.1 NMSA 1978 (being Laws 1985,
Chapter 19, Section 1) is amended to read:

"2-3-14.1. STATE AGENCIES--REPORTS.--[A.] No state
agency shall submit or send to the members of the legislature
any material, other than proposed legislation, in excess of
[five] three pages.

~~[B. Nothing in this section shall limit the
response of any agency to a direct request of a legislator or
group of legislators nor the submission of the executive
budget.]~~

1 C. ~~All reports to the legislature by a state~~
2 ~~agency shall be filed in duplicate with the legislative~~
3 ~~council service and such reports shall not be subject to the~~
4 ~~page limitations of this section. The service shall compile a~~
5 ~~list of the reports submitted prior to each regular~~
6 ~~legislative session since the beginning of the previous~~
7 ~~regular session, listing the title and agency and distribute~~
8 ~~the list among the legislators during the first week of the~~
9 ~~session.~~

10 D. ~~Any legislator may request any report,~~
11 ~~including those listed pursuant to Subsection C of this~~
12 ~~section. Upon such a request, the state agency shall furnish~~
13 ~~the report to the legislator.~~

14 E. ~~Compliance by a state agency with Subsection C~~
15 ~~of this section shall fulfill any requirement of a state~~
16 ~~agency to report to the legislature, unless the requirement is~~
17 ~~specifically exempted from the requirements of this section.~~

18 F. ~~No state agency shall submit material bound~~
19 ~~other than by staples unless the bulk or other qualities of~~
20 ~~the material require other bindings; provided that, in all~~
21 ~~cases, the most economical method of binding and packaging~~
22 ~~shall be used.~~

23 G.] For the purposes of this section, "state
24 agency" means any agency, division or instrumentality of the
25 state. ~~[but does not include political subdivisions and~~
