WHEREAS, one hundred twenty-six thousand nurses are needed to fill hospital vacancies nationwide; and

WHEREAS, vacancy rates in New Mexico are approximately twenty percent for registered nurses, twelve to fifteen percent for licensed practical nurses and eleven to twenty percent for certified nursing assistants; and

WHEREAS, vacancies for nursing positions with the public health division of the department of health exceed one hundred; and

WHEREAS, the average age of registered nurses is over forty-three years nationally and over forty-six years in New . 139697.1

- recommendations for the development of state-F. supported education programs to allow rapid realignment of existing programs or development of new programs;
