CAPITAL PROJECTS IN FORT SUMNER IN DE BACA COUNTY

This capital outlay request is revised to read as follows:

- to the aging and long-term services department

FT SUMNER SENIOR CENTER CONSTRUCT

seven hundred twenty-five thousand dollars (\$725,000) to plan, design, construct, improve, equip and furnish the senior center in Fort Sumner in De Baca county

- to the department of environment

FT SUMNER WATER/WASTEWATER SYSTEM BLDG

fifty thousand dollars (\$50,000) to plan, design, construct and equip water and wastewater system improvements, including a storage building at the wastewater treatment plant, in Fort Sumner in De Baca county

FT SUMNER WATER/WASTEWATER SYSTEM IMPROVE

four hundred thousand dollars (\$400,000) to plan, design and construct water and wastewater system improvements, including line and valve replacements and purchase and installation of hydrants and security fencing, in Fort Sumner in De Baca county

FT SUMNER WATER/WASTEWATER SYSTEM MANHOLES/LINES

three hundred fifty thousand dollars (\$350,000) to plan, design and construct water and wastewater system improvements, including repair and replacement of manholes and collection lines, in Fort Sumner in De Baca county

- to the department of transportation

14TH STREET IMPROVE-FT SUMNER

three hundred fifty thousand dollars (\$350,000) to plan, design and construct improvements to Fourteenth street from Sumner avenue to avenue E in Fort Sumner in De Baca county

17TH STREET IMPROVE-FT SUMNER

five hundred twenty-five thousand dollars (\$525,000) to plan, design and construct improvements to Seventeenth street in Fort Sumner in De Baca county

FT SUMNER AIRPORT/INDUSTRIAL PARK IMPROVE

three hundred thousand dollars (\$300,000) to plan, design and construct improvements and an expansion to the airport industrial park, including renovation of the hangar, in Fort Sumner in De Baca county

- to the local government division of the department of finance and administration

FT SUMNER CITY HALL INFO TECH

fifty thousand dollars (\$50,000) to purchase and install information technology in city hall in Fort Sumner in De Baca county

FT SUMNER COMMUNITY CENTER RENOVATE

two hundred seventy-five thousand dollars (\$275,000) to renovate the community center in Fort Sumner in De Baca county

FT SUMNER FIRE STATION RENOVATE

two hundred thousand dollars (\$200,000) to construct improvements, including roof repairs, to the fire station in Fort Sumner in De Baca county

FT SUMNER FRONT-END LOADER

one hundred fifty thousand dollars (\$150,000) to purchase a front-end loader for Fort Sumner in De Baca county

FT SUMNER LIBRARY EXPAND

one hundred thousand dollars (\$100,000) to construct an expansion to the public library in Fort Sumner in De Baca county

FT SUMNER PUBLIC SAFETY COMPLEX EXPAND

three hundred thirty thousand dollars (\$330,000) to renovate and expand the public safety complex in Fort Sumner in De Baca county

FT SUMNER ROAD GRADER

two hundred thousand dollars (\$200,000) to purchase a road grader for Fort Sumner in De Baca county
