CAPITAL PROJECTS IN DE BACA COUNTY

This capital outlay request is revised to read as follows:

- to the department of environment

DE BACA CO TRANSFER STATION

four hundred fifty thousand dollars (\$450,000) to plan, design and construct a transfer station in De Baca county

- to the local government division of the department of finance and administration

DE BACA CO ASSESSOR/CLERK/TREAS OFFICE COPIERS

twelve thousand five hundred dollars (\$12,500) to purchase copy machines for the county assessor's, clerk's and treasurer's offices in De Baca county

DE BACA CO ASSESSOR'S OFFICE PLOTTER

thirty thousand dollars (\$30,000) to purchase and install a plotter at the assessor's office in De Baca county

DE BACA CO CLERK'S OFFICE VOTING MACHINES

forty thousand dollars (\$40,000) to purchase and install voting machines that comply with the Help America Vote Act of 2002 for the county clerk's office in De Baca county

DE BACA CO COURTHOUSE CONVENIENCE STATION

three thousand dollars (\$3,000) to plan, design and construct a convenience station in the dispatch center of the courthouse in De Baca county

DE BACA CO COURTHOUSE RESTROOMS

fifty thousand dollars (\$50,000) to plan, design and construct handicapped-accessible restrooms at the courthouse in De Baca county

DE BACA CO COURTHOUSE ROOF & HVAC

sixty thousand dollars (\$60,000) to repair the roof and purchase and install a heating, ventilation and air conditioning system at the courthouse in De Baca county

DE BACA CO COURTHOUSE WALL/STEPS

twenty-five thousand dollars (\$25,000) to plan, design and construct a retaining wall and steps at the courthouse in De Baca county

DE BACA CO DAYCARE PROJECT EQUIP & FURNISH

thirty-five thousand dollars (\$35,000) to purchase and install kitchen equipment, fixtures and furnishings for the daycare project in De Baca county

DE BACA CO SHERIFF DEPT/DETEN FCLTY INFO TECH/FURN

nine thousand dollars (\$9,000) to purchase and install information technology and office furniture in the sheriff's department and detention facility in De Baca county

DE BACA CO SHERIFF'S VEHICLE

twenty-seven thousand dollars (\$27,000) to purchase and equip a vehicle for the sheriff's department in De Baca county

DE BACA CO TRAILERS

eighty-five thousand dollars (\$85,000) to purchase trailers for De Baca county
