SUMMARY

Synopsis of Bill

Senate Joint Memorial 41 (SJM 41) asks the Energy, Minerals and Natural Resources Department to establish and administer a Low-Income Energy Advisory Committee.

FISCAL IMPLICATIONS

EMNRD indicates that the agency's Energy Conservation and Management Division (ECMD) will need general fund administrative funds to carry out this initiative. The operating budget requested for operational expenses would assist ECMD to carry out the requirements of SJM 41. It is estimated that this would take 2 days of two FTEs staff time every other month to staff committee meetings.

SIGNIFICANT ISSUES

EMNRD states, "During 2008, representatives from utility companies, rural electric cooperatives, nonprofit organizations with an interest in energy efficiency, community advocates of the environment and clean energy, the New Mexico Mortgage Finance Authority, Human

Services Department, Public Regulation Commission, and the Energy, Minerals and Natural Resources Department met to gain a thorough understanding of the need for low-income families to receive weatherization, utility bill payment and energy efficiency assistance. Consensus was reached on how to address these issues, as seen in HB 732. What remains in addressing these issues is a mechanism for continuing to communicate and coordinate current disparate efforts to provide energy related assistance to the poor of New Mexico. This memorial asks that these efforts continue, by formally establishing a Low-Income Energy Advisory Committee, and that EMNRD be designated to coordinate such a committee."

PERFORMANCE IMPLICATIONS

ADMINISTRATIVE IMPLICATIONS

EMNRD indicates it will be required to administer SJM 41, and that Energy Conservation and Management Division has the staff expertise needed to administer the task force. (See Fiscal Implications)
