A MEMORIAL

REQUESTING THE PUBLIC EDUCATION DEPARTMENT TO COLLABORATE WITH
STATE INSTITUTIONS OF HIGHER LEARNING, GIFTED EDUCATION
ORGANIZATIONS AND THE LEGISLATIVE EDUCATION STUDY COMMITTEE TO
DETERMINE THE REQUIREMENTS FOR A GIFTED EDUCATION ENDORSEMENT
ON TEACHING LICENSES.

WHEREAS, studies show that gifted students have unique
needs that require accommodations and modifications at school;
and

WHEREAS, it is important that public schools meet the
needs of gifted students and help them to realize their
potential and maintain their motivation to learn; and

WHEREAS, research shows that in order to meet these
needs, gifted education teachers must be specifically trained
and highly qualified; and

1 WHEREAS, highly qualified gifted education teachers are
2 not only better prepared to meet the needs of gifted students
3 but are a resource to general education teachers to assist in
4 the differentiation of instruction to the benefit of all
5 students; and

6 WHEREAS, in New Mexico, during the 2006-2007 school year,
7 over thirteen thousand students were identified as gifted and
8 were provided services by over seven hundred gifted education
9 teachers, even though the state licensure system does not fully
10 recognize the special requirements and talents of teachers of
11 gifted students;

12 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
13 REPRESENTATIVES OF THE STATE OF NEW MEXICO that the public
14 education department be requested to collaborate with state
15 institutions of higher learning, gifted education organizations
16 and the legislative education study committee to determine the
17 requirements and competencies for a gifted education
18 endorsement on teaching licenses; and

19 BE IT FURTHER RESOLVED that the department take into
20 consideration the existing coursework at the colleges of
21 education at the state institutions of higher education that
22 offer specialized gifted education programs for students; and

23 BE IT FURTHER RESOLVED that the department's study
24 consider endorsement competencies for gifted education
25 teachers, such as those proposed in the *Technical Assistance*

1 *Manual for Gifted Education in New Mexico*, and existing
2 portfolio guidelines for gifted education, such as those
3 developed by the New Mexico association for the gifted; and

4 BE IT FURTHER RESOLVED that the study also identify
5 assessments currently available in gifted education that could
6 be adopted within New Mexico as an appropriate gifted education
7 examination that would demonstrate that gifted education-
8 endorsed teachers are highly qualified, such as the "Education
9 Testing Service PRAXIS II Gifted Exam"; and

10 BE IT FURTHER RESOLVED that copies of this memorial be
11 transmitted to the public education department, the deans of
12 the colleges of education at the state institutions of higher
13 learning, the New Mexico association for the gifted and the
14 legislative education study committee.
