AN ACT

RELATING TO CULTURE; CREATING A MUSIC COMMISSION STAFF
POSITION; ESTABLISHING POSITION DUTIES; MAKING AN
APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 18-16-1 NMSA 1978 (being Laws 2009,
Chapter 13, Section 1) is amended to read:

"18-16-1. SHORT TITLE.--~~[This act]~~ Chapter 18, Article 16
NMSA 1978 may be cited as the "Music Commission Act"."

SECTION 2. A new section of the Music Commission Act is
enacted to read:

"[NEW MATERIAL] COMMISSION STAFF POSITION--
CREATED--DUTIES.--"

A. A member of the staff of the division shall be
dedicated to overseeing programs of the commission.

1 B. Subject to the policies agreed to by the
2 commission, the member of the staff shall:

3 (1) report to the director of the division;
4 (2) oversee the commission in its performance
5 of duties;

6 (3) collaborate with other state agencies,
7 including the New Mexico film division and other divisions of
8 the economic development department, the tourism development
9 division of the tourism department, the public education
10 department and the cultural affairs department, to assist the
11 commission in performing its duties;

12 (4) advocate for the economic development of
13 the state's music and music education industries; and

14 (5) perform other duties as directed by the
15 commission or as provided by law."

16 **SECTION 3. APPROPRIATION.--**

17 A. Eighty thousand dollars (\$80,000) is
18 appropriated from the general fund to the cultural affairs
19 department for expenditure in fiscal year 2014 for the
20 following purposes:

21 (1) sixty thousand dollars (\$60,000) for a
22 music commission staff position; and

23 (2) twenty thousand dollars (\$20,000) for
24 music commission programs, services or operations.

25 B. Any unexpended or unencumbered balance remaining
