one million seven hundred fifty thousand dollars (\$1,750,000) to plan, design, construct, purchase, install, equip and furnish improvements and repairs, including security systems, exhibits, a theater and heating, ventilation and air conditioning systems, at the New Mexico museum of space history in Alamogordo in Otero county

five hundred thousand dollars (\$500,000) for phase 1 design, construction and purchase of property, rights of way and easements for the Brown farm flood control project in Dona Ana county
