20 more than seven thousand five hundred children each year; and

21 WHEREAS, the national dance institute of New Mexico has
22 served seventy thousand children across the state since its
23 inception; and

25 statewide nonprofit organization dedicated to improving the

7 WHEREAS, the purpose of the national dance institute of
8 New Mexico's distinctive programs is to help children develop
9 discipline, a standard of excellence and a belief in themselves
10 that will carry over into all aspects of their lives; and

11 WHEREAS, independent research shows that the national
12 dance institute of New Mexico's award-winning programs
13 positively impact children's academic achievement, health,
14 quality of life and self-efficacy through consistent messaging,
15 skill building and by providing positive role models; and

16 WHEREAS, the Wallace foundation, a national leader in arts
17 organization programming and management, endorsed the national
18 dance institute of New Mexico as an "exemplary" program for the
19 development of youth in the United States; and

20 WHEREAS, the national dance institute of New Mexico is a
21 public-private partnership that collaborates with federal,
22 state and local government entities; public schools and school
23 districts; businesses; individuals; and foundations to promote
24 a platform for children's success and to develop educated,
25 productive and engaged citizens who will create successful
