10 AN ACT

11 RELATING TO PUBLIC SCHOOLS; REMOVING THE REQUIREMENT THAT A
12 STUDENT TAKE AT LEAST ONE ADVANCED PLACEMENT, HONORS, DUAL-
13 CREDIT OR DISTANCE LEARNING COURSE FOR GRADUATION.

15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

16 SECTION 1. Section 22-13-1.1 NMSA 1978 (being Laws 1986,
17 Chapter 33, Section 5, as amended by Laws 2014, Chapter 9,
18 Section 3 and by Laws 2014, Chapter 70, Section 1 and also by
19 Laws 2014, Chapter 71, Section 1) is amended to read:

20 "22-13-1.1. GRADUATION REQUIREMENTS.--

21 A. At the end of grades eight through eleven, each
22 student shall prepare an interim next-step plan that sets forth
23 the coursework for the grades remaining until high school
24 graduation. Each year's plan shall explain any differences
25 from previous interim next-step plans, shall be filed with the

1 principal of the student's high school and shall be signed by
2 the student, the student's parent and the student's guidance
3 counselor or other school official charged with coursework
4 planning for the student.

5 B. Each student must complete a final next-step
6 plan during the senior year and prior to graduation. The plan
7 shall be filed with the principal of the student's high school
8 and shall be signed by the student, the student's parent and
9 the student's guidance counselor or other school official
10 charged with coursework planning for the student.

11 C. An individualized education program that meets
12 the requirements of Subsections A and B of this section and
13 that meets all applicable transition and procedural
14 requirements of the federal Individuals with Disabilities
15 Education Act for a student with a disability shall satisfy the
16 next-step plan requirements of this section for that student.

17 D. A local school board shall ensure that each high
18 school student has the opportunity to develop a next-step plan
19 based on reports of college and workplace readiness
20 assessments, as available, and other factors and is reasonably
21 informed about:

22 (1) curricular and course options, including
23 honors or advanced placement courses, dual-credit courses,
24 distance learning courses, career clusters, pre-apprenticeship
25 programs or remediation programs that the college and workplace

1 readiness assessments indicate to be appropriate;

2 (2) opportunities available that lead to
3 different post-high-school options; and

4 (3) alternative opportunities available if the
5 student does not finish a planned curriculum.

6 E. The secretary shall:

7 (1) establish specific accountability
8 standards for administrators, counselors, teachers and school
9 district staff to ensure that every student has the opportunity
10 to develop a next-step plan;

11 (2) promulgate rules for accredited private
12 schools in order to ensure substantial compliance with the
13 provisions of this section;

14 (3) monitor compliance with the requirements
15 of this section; and

16 (4) compile such information as is necessary
17 to evaluate the success of next-step plans and report annually,
18 by December 15, to the legislative education study committee
19 and the governor.

20 F. Once a student has entered ninth grade, the
21 graduation requirements shall not be changed for that student
22 from the requirements specified in the law at the time the
23 student entered ninth grade.

24 G. Successful completion of a minimum of twenty-
25 three units aligned to the state academic content and

1 performance standards shall be required for graduation. These
2 units shall be as follows:

3 (1) four units in English, with major emphasis
4 on grammar and literature;

5 (2) three units in mathematics, at least one
6 of which is equivalent to the algebra 1 level or higher;

7 (3) two units in science, one of which shall
8 have a laboratory component; provided, however, that with
9 students entering the ninth grade beginning in the 2005-2006
10 school year, three units in science shall be required, one of
11 which shall have a laboratory component;

12 (4) three units in social science, which shall
13 include United States history and geography, world history and
14 geography and government and economics;

15 (5) one unit in physical education;

16 (6) one unit in communication skills or
17 business education, with a major emphasis on writing and
18 speaking and that may include a language other than English;

19 (7) one-half unit in New Mexico history for
20 students entering the ninth grade beginning in the 2005-2006
21 school year; and

22 (8) nine elective units and seven and one-half
23 elective units for students entering the ninth grade in the
24 2005-2006 school year that meet department content and
25 performance standards. Student service learning shall be

1 offered as an elective. Financial literacy shall be offered as
2 an elective. Pre-apprenticeship programs may be offered as
3 electives. Media literacy may be offered as an elective.

4 ~~[H. For students entering the ninth grade beginning~~
5 ~~in the 2009-2010 school year, at least one of the units~~
6 ~~required for graduation shall be earned as an advanced~~
7 ~~placement or honors course, a dual-credit course offered in~~
8 ~~cooperation with an institution of higher education or a~~
9 ~~distance learning course.~~

10 ~~F.]~~ H. The department shall establish a procedure
11 for students to be awarded credit through completion of
12 specified career technical education courses for certain
13 graduation requirements.

14 ~~[J.]~~ I. Successful completion of the requirements
15 of the New Mexico diploma of excellence shall be required for
16 graduation for students entering the ninth grade beginning in
17 the 2009-2010 school year. Successful completion of a minimum
18 of twenty-four units aligned to the state academic content and
19 performance standards shall be required to earn a New Mexico
20 diploma of excellence. These units shall be as follows:

21 (1) four units in English, with major emphasis
22 on grammar, nonfiction writing and literature;

23 (2) four units in mathematics, of which one
24 shall be the equivalent to or higher than the level of algebra
25 2, unless the parent submitted written, signed permission for

1 the student to complete a lesser mathematics unit; and provided
2 that a financial literacy course that meets state mathematics
3 academic content and performance standards shall qualify as one
4 of the four required mathematics units;

5 (3) three units in science, two of which shall
6 have a laboratory component;

7 (4) three and one-half units in social
8 science, which shall include United States history and
9 geography, world history and geography, government and
10 economics and one-half unit of New Mexico history;

11 (5) one unit in physical education, as
12 determined by each school district, which may include a
13 physical education program that meets state content and
14 performance standards or participation in marching band, junior
15 reserve officers' training corps or interscholastic sports
16 sanctioned by the New Mexico activities association or any
17 other co-curricular physical activity;

18 (6) one unit in one of the following:
19 a career cluster course, workplace readiness or a language
20 other than English; and

21 (7) seven and one-half elective units that
22 meet department content and performance standards. Student
23 service learning shall be offered as an elective. Financial
24 literacy shall be offered as an elective. Pre-apprenticeship
25 programs may be offered as electives. Media literacy may be

2 ~~[K-]~~ J. For students entering the eighth grade in
3 the 2012-2013 school year, a course in health education is
4 required prior to graduation. Health education may be required
5 in either middle school or high school, as determined by the
6 school district. Each school district shall submit to the
7 department by the beginning of the 2011-2012 school year a
8 health education implementation plan for the 2012-2013 and
9 subsequent school years, including in which grade health
10 education will be required and how the course aligns with
11 department content and performance standards. Health education
12 shall include age-appropriate sexual abuse and assault
13 awareness and prevention training that meets department
14 standards developed in consultation with the federal centers
15 for disease control and prevention that are based on evidence-
16 based methods that have proven to be effective.

17 ~~[H-]~~ K. Final examinations shall be administered to
18 all students in all classes offered for credit.

19 ~~[M-]~~ L. Until July 1, 2010, a student who has not
20 passed a state graduation examination in the subject areas of
21 reading, English, mathematics, writing, science and social
22 science shall not receive a high school diploma. The state
23 graduation examination on social science shall include a
24 section on the constitution of the United States and the
25 constitution of New Mexico. If a student exits from the school

1 system at the end of grade twelve without having passed a state
2 graduation examination, the student shall receive an
3 appropriate state certificate indicating the number of credits
4 earned and the grade completed. If within five years after a
5 student exits from the school system the student takes and
6 passes the state graduation examination, the student may
7 receive a high school diploma. Any student passing the state
8 graduation examination and completing all other requirements
9 within five years of entering ninth grade, including a final
10 summer session if completed by August 1, may be counted by the
11 school system in which the student is enrolled as a high school
12 graduate for the year in which completion and examination
13 occur.

14 ~~[N-]~~ M. Beginning with the 2010-2011 school year, a
15 student shall not receive a New Mexico diploma of excellence if
16 the student has not demonstrated competence in the subject
17 areas of mathematics, reading and language arts, writing,
18 social studies and science, including a section on the
19 constitution of the United States and the constitution of
20 New Mexico, based on a standards-based assessment or
21 assessments or a portfolio of standards-based indicators
22 established by the department by rule. The standards-based
23 assessments required in Section 22-2C-4 NMSA 1978 may also
24 serve as the assessment required for high school graduation.
25 If a student exits from the school system at the end of grade

1 twelve without having satisfied the requirements of this
2 subsection, the student shall receive an appropriate state
3 certificate indicating the number of credits earned and the
4 grade completed. If within five years after a student exits
5 from the school system the student satisfies the requirement of
6 this subsection, the student may receive a New Mexico diploma
7 of excellence. Any student satisfying the requirements of this
8 subsection and completing all other requirements within five
9 years of entering ninth grade, including a final summer session
10 if completed by August 1, may be counted by the school system
11 in which the student is enrolled as a high school graduate for
12 the year in which all requirements are satisfied.

13 ~~[0-]~~ N. As used in this section:

14 (1) "final next-step plan" means a next-step
15 plan that shows that the student has committed or intends to
16 commit in the near future to a four-year college or university,
17 a two-year college, a trade or vocational program, an
18 internship or apprenticeship, military service or a job;

19 (2) "interim next-step plan" means an annual
20 next-step plan in which the student specifies post-high-school
21 goals and sets forth the coursework that will allow the student
22 to achieve those goals; and

23 (3) "next-step plan" means an annual personal
24 written plan of studies developed by a student in a public
25 school or other state-supported school or institution in

1 consultation with the student's parent and school counselor or
2 other school official charged with coursework planning for the
3 student that includes one or more of the following:

4 (a) advanced placement or honors
5 courses;

6 (b) dual-credit courses offered in
7 cooperation with an institution of higher education;

8 (c) distance learning courses;

9 (d) career-technical courses; and

10 (e) pre-apprenticeship programs.

11 [~~P-~~] O. The secretary may establish a policy to
12 provide for administrative interpretations to clarify
13 curricular and testing provisions of the Public School Code."
