11 RELATING TO VETERANS' SERVICES; TRANSFERRING THE OPERATIONAL
12 AUTHORITY AND PERSONAL PROPERTY OF VIETNAM VETERANS MEMORIAL
13 STATE PARK IN COLFAX COUNTY FROM THE ENERGY, MINERALS AND
14 NATURAL RESOURCES DEPARTMENT TO THE VETERANS' SERVICES
15 DEPARTMENT UPON THE TRANSFER OF THE REAL PROPERTY OF VIETNAM
16 VETERANS MEMORIAL STATE PARK IN COLFAX COUNTY FROM THE ENERGY,
17 MINERALS AND NATURAL RESOURCES DEPARTMENT TO THE GENERAL
18 SERVICES DEPARTMENT.

20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

21 SECTION 1. TEMPORARY PROVISION--TRANSFERS OF FUNCTIONS,
22 PERSONNEL, APPROPRIATIONS, MONEY, PROPERTY, CONTRACTUAL
23 OBLIGATIONS AND REFERENCES.--

24 A. Upon ratification of the transfer of the real
25 property of Vietnam Veterans Memorial state park in Colfax

1 county from the energy, minerals and natural resources
2 department to the general services department, all programs,
3 functions, personnel, appropriations, money, records,
4 furniture, equipment, supplies and other property belonging to
5 the energy, minerals and natural resources department
6 pertaining to Vietnam Veterans Memorial state park in Colfax
7 county shall be transferred to the veterans' services
8 department.

9 B. Upon ratification of the transfer of the real
10 property of Vietnam Veterans Memorial state park in Colfax
11 county from the energy, minerals and natural resources
12 department to the general services department, all contractual
13 obligations of the energy, minerals and natural resources
14 department pertaining to any of the functions delineated in
15 Subsection A of this section shall be transferred to the
16 veterans' services department.

17 C. Upon ratification of the transfer of the real
18 property of Vietnam Veterans Memorial state park in Colfax
19 County from the energy, minerals and natural resources
20 department to the general services department, all references
21 in law to the energy, minerals and natural resources department
22 pertaining to any of the functions delineated in Subsection A
23 of this section shall be transferred to the veterans' services
24 department.
