WHEREAS, the Aggies in crimson were led by running back Larry Rose III, who finished the game with one hundred fortytwo yards rushing and forty-eight yards receiving; and

WHEREAS, Larry Rose III scored on a twenty-one yard touchdown run to clinch the game in the first overtime possession and seal the school's first bowl game win in fiftyseven years and its third bowl game victory in the school's history; and

WHEREAS, New Mexico state university head football coach Doug Martin said of the victory: "I'm just thrilled for these kids and this community. Just look at these fans who showed up here. This is an unbelievable day for us.";
