AN ACT

RELATING TO CHILD SAFETY; REQUIRING THE PUBLIC EDUCATION DEPARTMENT AND THE CHILDREN, YOUTH AND FAMILIES DEPARTMENT TO WORK TOGETHER TO DEVELOP A SYSTEM TO TRACK CHILDREN MOVING BETWEEN PUBLIC SCHOOLS AND CHILDREN, YOUTH AND FAMILIES DEPARTMENT SERVICES; REQUIRING THE SYSTEM TO BE USABLE BY BOTH DEPARTMENTS AND PUBLIC SCHOOLS TO TRACK CHILDREN UNDER THE AGE OF EIGHTEEN; CREATING A TASK FORCE; REQUIRING THE EXPERTISE OF THE DEPARTMENT OF INFORMATION TECHNOLOGY; CLARIFYING THAT THE STUDENT IDENTIFICATION NUMBER ASSIGNED TO EACH STUDENT REQUIRED IN THE PUBLIC SCHOOL CODE IS A UNIQUE NUMBER AND SHALL NEVER BE USED FOR ANOTHER STUDENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**SECTION 1.** A new section of the Public School Code is enacted to read:

1           "[NEW MATERIAL] STUDENT IDENTIFICATION NUMBER UNIQUE TO  
2 THAT STUDENT.--The student identification number required  
3 pursuant to Section 22-2C-11 NMSA 1978 shall be unique to each  
4 student and shall not be used or assigned to another student.  
5 That number shall be on all forms, student records, transcripts  
6 and databases in which a student is identified by name. A  
7 student shall be assigned only one identification number. It  
8 shall be the responsibility of every school district and  
9 charter school in the state to determine if the student has  
10 ever enrolled previously in a public school in New Mexico, and  
11 school districts and charter schools shall use the original  
12 student identification number."

13           **SECTION 2. TEMPORARY PROVISIONS--COMPATIBLE TRACKING**  
14 **SYSTEM BETWEEN PUBLIC SCHOOLS, THE PUBLIC EDUCATION DEPARTMENT**  
15 **AND THE CHILDREN, YOUTH AND FAMILIES DEPARTMENT--TASK FORCE--**  
16 **MEMBERSHIP--DIRECTIVE--DEPARTMENT OF INFORMATION TECHNOLOGY**  
17 **ASSISTANCE.--**

18           A. The public education department and the  
19 children, youth and families department shall develop a  
20 compatible student-child tracking system that is usable among  
21 public schools, the public education department and the  
22 children, youth and families department and local offices. The  
23 departments shall consider if there are other users that should  
24 be included in the system.

25           B. The departments shall convene a task force of

1 public school personnel; school and children, youth and  
2 families department social workers; juvenile probation and  
3 parole personnel; children's court judges or their designees;  
4 and child advocates. The task force, with the assistance of  
5 systems analysts from the two departments and the department of  
6 information technology, shall develop the tracking system.  
7 Task force members shall be appointed by the secretaries of  
8 public education and children, youth and families.

9 C. The task force shall work to develop a tracking  
10 system that:

- 11 (1) provides for real-time reporting; and
  - 12 (2) allows for the cross-checking of the
- 13 student identification number assigned by a New Mexico public  
14 school pursuant to Section 22-2C-11 NMSA 1978, the uniform case  
15 number required by Section 32A-20-1 NMSA 1978 for neglected and  
16 abused children and any other identification numbers used by  
17 the children, youth and families department for other children  
18 it serves.

19 D. The task force shall report to the legislative  
20 education study committee with its design and recommendations  
21 for implementation of the tracking system by December 1, 2019.
