11	RELATING TO LIQUOR LICENSES; PROVIDING FOR THE ISSUANCE OF
12	DISPENSER'S LICENSES TO MUNICIPALITIES AND THE LEASE OF THOSE
13	LICENSES TO QUALIFIED LESSEES; PERMITTING WHOLESALERS TO SELL
14	OR OFFER TO SELL ALCOHOLIC BEVERAGES TO QUALIFIED LESSEES.

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	SECTION 1. Section 60-6A-1 NMSA 1978 (being Laws 1981,
18	Chapter 39, Section 18, as amended) is amended to read:
19	"60-6A-1. WHOLESALER'S LICENSE
20	A. In any local option district, a person qualified
21	under the provisions of the Liquor Control Act may apply for
22	and be issued a license as a wholesaler of alcoholic beverages.
23	B. [No] <u>A</u> wholesaler shall <u>not</u> sell, offer for sale
24	or ship alcoholic beverages [not] received at and shipped from
25	a premises other than the premises specified in the

<u>underscored material = new</u> [bracketed material] = delete wholesaler's license. As used in this section, "received at and shipped from" means that all alcoholic beverages shall be unloaded at the wholesaler's licensed premises and placed into inventory before being sold and shipped to a licensed retailer.

C. [No] <u>A</u> wholesaler shall <u>not</u> sell or offer for sale alcoholic beverages to any person other than the holder of a New Mexico wholesaler's, retailer's, dispenser's, canopy, restaurant or club license; <u>a qualified lessee of a municipal</u> <u>dispenser's license</u>; a governmental licensee or its lessee; or an enterprise owned, operated or licensed by an Indian nation, tribe or pueblo within the state in conformity with an ordinance duly adopted by the Indian nation, tribe or pueblo having jurisdiction over the situs of the transaction within the area of Indian country, certified by the secretary of the interior, published in the federal register, according to the laws of the United States."

SECTION 2. A new section of the Liquor Control Act is enacted to read:

"[<u>NEW MATERIAL</u>] MUNICIPAL DISPENSER'S LICENSE.--

A. Upon request of the governing body of a municipality that is, or that is located in, a local option district, the director shall, for each twenty thousand inhabitants of the municipality as shown by the last federal decennial census, issue to the municipality a municipal dispenser's license.

1 A municipality may lease a municipal dispenser's Β. 2 license to a qualified lessee, who shall be subject to the provisions of the Liquor Control Act and all rules governing 3 dispensers, including annual renewal fees and taxes; provided 4 that the qualified lessee shall have no property right in the 5 municipal dispenser's license. 6 7 C. A municipal dispenser's license shall: (1)be used for the sole purpose of being 8 9 leased to a qualified lessee; not be transferred; and 10 (2) (3) not expire. 11 12 D. A municipality shall not be liable or accountable for the use of its municipal dispenser's license, 13 including liability for a violation of the Liquor Control Act 14 and for fees and taxes charged against the license.
