A MEMORIAL

RECOGNIZING THAT NEW MEXICO IS AT SERIOUS RISK OF AN UNDERCOUNT
IN THE 2020 CENSUS AND REQUESTING SUPPORT TO CARRY OUT THE
NECESSARY STEPS TO ENSURE A COMPLETE AND ACCURATE COUNT OF ALL
NEW MEXICO RESIDENTS FOR THE UPCOMING 2020 CENSUS.

WHEREAS, obtaining an accurate population count is so
vital to representative democracy that the framers of the
United States constitution addressed the issue of the census
and congressional reapportionment in the opening paragraphs of
the constitution; and

WHEREAS, a decennial census is the count of "the whole
number of persons in each State" in accordance with Article 1,
Section 2 and Section 2 of the fourteenth amendment to the
United States constitution; and

WHEREAS, the decennial census is used to apportion seats

1 in the house of representatives among the states; and

2 WHEREAS, to ensure that the people have fair and equal
3 representation, accurate census population counts serve as the
4 basis for redistricting the state legislature, as well as
5 regional and local governing bodies; and

6 WHEREAS, accurate census data is vital to businesses
7 deciding where to build factories, offices and stores and
8 create jobs, to developers determining where to build new homes
9 and revitalize old neighborhoods and to local governments
10 planning for public safety and emergency preparedness; and

11 WHEREAS, the census is a key source of data used in social
12 science, health and environment research; and

13 WHEREAS, billions of dollars of annual federal assistance
14 are distributed to states on a per capita basis using census
15 data; and

16 WHEREAS, an accurate census count is absolutely vital to
17 New Mexico insofar as the state benefits from as much as seven
18 billion eight hundred million dollars (\$7,800,000,000) a year
19 in funding for fifty-four different programs, including
20 medicaid, the children's health insurance program, the
21 supplemental nutrition assistance program, Pell grants,
22 community development block grants and highway planning and
23 construction; and

24 WHEREAS, certain population groups, referred to as "hard-
25 to-count", are at a higher risk of not being fully counted in

2 WHEREAS, a number of demographic and geographic factors
3 contribute to New Mexico being especially vulnerable to an
4 undercount, such as its large Native American and Hispanic
5 populations, high poverty rates, immigrant populations and vast
6 rural areas; and

7 WHEREAS, based on the latest United States census bureau
8 estimates, forty-three percent of New Mexico's population, or
9 almost nine hundred thousand residents, live in neighborhoods
10 designated as hard-to-count; and

11 WHEREAS, being forty-ninth in the nation in the percentage
12 of households with broadband internet access, New Mexico will
13 be further exposed to increased undercount vulnerability due to
14 a major United States census bureau change in methodology to
15 rely on the internet as the primary way for households to
16 respond to the 2020 census; and

17 WHEREAS, in view of New Mexico's significant Hispanic and
18 immigrant populations, the United States department of
19 commerce's decision that a citizenship question be included in
20 the survey is another new and distressing factor expected to
21 discourage participation, further exacerbating the risk of an
22 undercount; and

23 WHEREAS, New Mexico will be the state hardest hit by this
24 unconstitutional attempt to suppress participation in the
25 census that would lead to an illegal undercount of the

2 WHEREAS, New Mexico loses at least fifty million dollars
3 (\$50,000,000) in federal assistance each year for every one
4 percent undercount; and

5 WHEREAS, the attorneys general from seventeen states,
6 including New Mexico; the District of Columbia; six major
7 cities; the United States conference of mayors; and other
8 entities have brought a lawsuit against the United States
9 department of commerce and the United States census bureau to
10 block the addition of the citizenship question;

11 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
12 REPRESENTATIVES OF THE STATE OF NEW MEXICO that the house of
13 representatives support the plaintiffs in *New York v. United*
14 *States Department of Commerce* No. 1.18-CV-2921 (S.D.N.Y.) in
15 the citizenship question lawsuit; and

16 BE IT FURTHER RESOLVED that the house of representatives
17 support a robust outreach effort to New Mexico residents
18 through direct, in-person outreach in multiple languages; and

19 BE IT FURTHER RESOLVED that the house of representatives
20 recognize the need for resources to be made available for
21 grants to tribal governments, city and county governments and
22 nonprofit groups to support their own outreach efforts in their
23 communities; and

24 BE IT FURTHER RESOLVED that the house of representatives
25 support the efforts of the state demographer to identify hard-

1 to-count communities in New Mexico and that a system be
2 developed to prioritize efforts to ensure that all New Mexicans
3 are counted; and

4 BE IT FURTHER RESOLVED that the house of representatives
5 recognize the need for resources to be made available for
6 computers and navigators to assist community members in filling
7 out the census survey and for improving access to places with
8 public internet access; and

9 BE IT FURTHER RESOLVED that the house of representatives
10 support additional outreach efforts to those who are homeless,
11 living in poverty, living in rural areas without internet
12 access and not fluent in English, as well as immigrant families
13 and people of color; and

14 BE IT FURTHER RESOLVED that the house of representatives
15 support efforts to develop a strategic communications and
16 engagement campaign to raise awareness of and promote
17 participation in the census; and

18 BE IT FURTHER RESOLVED that copies of this memorial be
19 delivered to the director of the United States census bureau,
20 the secretary of the United States department of commerce, the
21 governor of New Mexico, the attorney general of New Mexico,
22 members of the New Mexico congressional delegation, the speaker
23 of the United States house of representatives, the president
24 pro tempore of the United States senate and the president of
25 the United States.
