A JOINT MEMORIAL  
REQUESTING THE SECRETARY OF PUBLIC EDUCATION TO EXPLORE METHODS  
TO REINSTATE AND SUPPORT MIDDLE SCHOOL FAMILY AND CONSUMER  
SCIENCES PROGRAMS.

WHEREAS, family and consumer sciences education is a field  
of study that focuses on families, work and their  
interrelationships; and

WHEREAS, New Mexico family and consumer sciences educators  
foster creativity in students and teach them to work  
effectively in teams to solve personal, family, community and  
real-world issues; and

WHEREAS, those educators engage students in relevant,  
hands-on strategies and reinforce principles of planning,  
managing and research; and

WHEREAS, family and consumer sciences courses encourage

4 curricula are designed to address current and extremely  
5 pressing issues that affect the well-being of New Mexico's

7 WHEREAS, New Mexico family and consumer sciences educators  
8 actively promote and develop science, computer literacy,  
9 engineering and mathematics literacy skills in youth, including  
10 critical thinking, reasoning and problem solving; and

11 WHEREAS, middle school family and consumer sciences  
12 programs enhance a student's knowledge in science with  
13 components focused on the global environment, food and  
14 nutritional sciences, safety and sanitation for cleaner  
15 environments and instruction on food borne illnesses; and

16 WHEREAS, middle school family and consumer sciences  
17 programs include computer literacy components focused on the  
18 use of computer-enhanced kitchen equipment, use of high-  
19 technology machines, computer presentations and other  
20 technology applications; and

21 WHEREAS, those programs also include engineering  
22 components involving interior design, home and kitchen design,  
23 textile design and manufacturing and product development and  
24 packaging; and

25 WHEREAS, the programs include mathematics components,

4 WHEREAS, middle school family and consumer sciences  
5 programs teach career exploration skills, including leadership,  
6 employability, team building, communication and time management  
7 skills; and

8 WHEREAS, middle schools with family and consumer sciences  
9 programs prepare young adults for healthy, sustainable and  
10 successful careers; and

11 WHEREAS, those programs are important in helping students  
12 build a strong foundation for employability, healthy  
13 relationships and vital life skills;

14 NOW THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE  
15 STATE OF NEW MEXICO that the public education department be  
16 requested to explore methods to reinstate and support middle  
17 school family and consumer sciences programs in New Mexico; and

18 BE IT FURTHER RESOLVED that the public education  
19 department be encouraged to inform superintendents and middle  
20 school principals of the necessity for these programs; and

21 BE IT FURTHER RESOLVED that by December 1, 2019, the  
22 secretary of public education be requested to report to the  
23 legislative education study committee recommendations to  
24 reinforce and support middle school family and consumer science  
25 programs; and
