AN ACT

RELATING TO THE REDISTRICTING OF THE HOUSE OF REPRESENTATIVES; ESTABLISHING REPRESENTATIVE DISTRICTS; PROVIDING THE METHOD FOR ELECTING REPRESENTATIVES; PROVIDING FOR THE FILLING OF VACANCIES; SETTING PRECINCTS; FIXING THE NUMBER, RESIDENCE AND TERMS OF REPRESENTATIVES; REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. SHORT TITLE.--This act may be cited as the "2021 House Redistricting Act".

SECTION 2. MEMBERSHIP.--The house of representatives is composed of seventy members to be elected from districts that are contiguous and that are as compact as is practicable.

SECTION 3. RESIDENCE.--At the time of filing a declaration of candidacy for the office of representative, a candidate shall reside in the district for which the candidate files. Thereafter, if a representative permanently removes the representative's residence from or maintains no residence in the district from which the representative was elected, the representative shall be deemed to have resigned, and a successor shall be selected as provided in Section 4 of the 2021 House Redistricting Act.

SECTION 4. ELECTIONS--VACANCIES.--

A. Members of the house of representatives shall

1 be elected for terms of two years.

2 B. If a vacancy occurs in the office of
3 representative for any reason, the vacancy shall be filled as
4 follows:

5 (1) for a representative district that is
6 situated wholly within the exterior boundaries of a single
7 county, the board of county commissioners of that county
8 shall appoint the representative to fill the vacancy; and

9 (2) for a representative district situated
10 within two or more counties:

11 (a) the board of county commissioners
12 of each county in the representative district shall submit
13 one name to the governor; and

14 (b) the governor shall appoint the
15 representative to fill the vacancy from the list of names so
16 submitted.

17 C. An appointment to fill a vacancy in the house
18 of representatives shall be for a term ending on December 31
19 after the next general election.

20 D. An appointment to fill a vacancy made before
21 the general election of 2022 shall be made from the district
22 as it was described in Section 2-7E-1 NMSA 1978, as
23 established by the court in *Egolf v. Duran*,
24 D-101-CV-2011-02942 (1st Dist. Ct., Judgment and Final Order
25 on Remand (State House of Representatives Trial) filed

1 February 28, 2012). On or after the general election of
2 2022, a vacancy shall be filled by appointment from the
3 district as set out in the 2021 House Redistricting Act.

4 **SECTION 5. PRECINCTS.--**

5 A. Precinct designations and boundaries used in
6 the 2021 House Redistricting Act are those precinct
7 designations and boundaries established pursuant to the
8 Precinct Boundary Adjustment Act and revised and approved
9 pursuant to that act by the secretary of state as of November
10 30, 2021.

11 B. A board of county commissioners shall not
12 create any precinct that lies in more than one representative
13 district and shall not divide any precinct so that the
14 divided parts of the precinct are situated in two or more
15 representative districts. Votes cast in any general, primary
16 or other statewide election from precincts created or divided
17 in violation of this subsection are invalid and shall not be
18 counted or canvassed.

19 **SECTION 6. DISTRICTS.--**The districts of the house of
20 representatives shall be as set out in Sections 7 through 76
21 of the 2021 House Redistricting Act.

22 **SECTION 7. REPRESENTATIVE DISTRICT ONE.--**Representative
23 district one is composed of San Juan county precincts 31, 39
