AN ACT

RELATING TO HEALTH; EXPANDING MEDICATION-ASSISTED TREATMENT PROGRAMS IN STATE CORRECTIONS FACILITIES; CREATING A FUND; MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO SECTION 1. MEDICATION-ASSISTED TREATMENT FOR THE INCARCERATED PROGRAM FUND--CREATED.--

9 Α. The "medication-assisted treatment for the 10 incarcerated program fund" is created as a nonreverting fund 11 in the state treasury. The fund consists of appropriations, 12 gifts, grants and donations. The human services department 13 shall administer the fund, and money in the fund is 14 appropriated to the human services department to assist all 15 counties that operate correctional facilities to establish 16 and operate medication-assisted treatment programs for people 17 who are incarcerated in county correctional facilities. 18 Disbursements from the fund shall be made by warrants of the 19 secretary of finance and administration pursuant to vouchers 20 signed by the secretary of human services.

B. No later than December 1, 2023, the human services department shall promulgate rules for the operation of medication-assisted treatment programs in correctional facilities in consultation with the corrections department, county corrections administrators and providers who

 experience working in corrections settings.

C. Beginning October 1, 2023 and annually thereafter, the human services department and the corrections department shall report to the interim legislative health and human services committee and the legislative finance committee on the establishment and operation of medication-assisted treatment programs in correctional facilities.

D. The corrections department shall:

(1) expand and continue to operate currently existing medication-assisted treatment programs for people who are incarcerated in a state correctional facility;

14 (2) by December 31, 2025, establish and 15 operate a medication-assisted treatment program to continue 16 medication-assisted treatment for incarcerated people with a 17 prescription who are booked into a state correctional 18 facility; and

19 (3) by the end of fiscal year 2026, offer
20 medication-assisted treatment to all people who are
21 incarcerated in state correctional facilities and in need of
22 medication-assisted treatment.

E. As used in this section:

(1) "correctional facility" means a prison or other detention facility, whether operated by a government

1	or private contractor, that is used for confinement of adult	
2	persons who are charged with or convicted of a violation of a	
3	law or an ordinance; and	
4	(2) "medication-assisted treatment" means
