#### **SUMMARY**

#### Synopsis of House Bill 431

House Bill 431 prohibits any local government agency (county, municipality, special district, or other political subdivision of the state) from restricting the type of fuel sources used by entities to serve their customers. Entities for purposes of this bill include a public or electric utility; an entity that generates, sells, or transmits electrical energy; a natural gas utility; a natural gas transmission company; or a liquefied petroleum gas dealer.

This prohibition would not apply to electric or gas utilities owned or operated by a government entity, and does not expand or alter the authority of the PRC over utilities.

This bill contains an emergency clause and would become effective immediately on signature by the governor.

### FISCAL IMPLICATIONS

The Public Regulation Commission (PRC) states there would be no additional operating impact if the bill were enacted, but does note that the PRC may receive increased consumer complaints regarding the restrictions in the bill. It is difficult to determine the number of complaints or cases that would result from the implementation of the bill.

### **SIGNIFICANT ISSUES**

The PRC notes that while complaints would likely come to the agency, the PRC does not have any authority to enforce or avoid the provisions of this bill.

The municipal league and the New Mexico Counties did not respond to requests for analysis for this bill, but enacting the legislation could significantly reduce local control over utilities.

It is unclear if the provisions of the legislation would hinder the state's ability to reach the requirements of the Energy Transition Act. The Environment Department and the Energy, Minerals and Natural Resources Department have been contacted to provide additional analysis.
