BILL SUMMARY

Synopsis: House Bill 103 proposes to make the crime of committing aggravated battery on a police officer a second degree felony when 1) inflicting great bodily harm; 2) doing so with a deadly weapon; or 3) doing so in any manner whereby great bodily harm or death can be inflicted.

Currently this crime is a third degree felony. Changing the degree of the felony from third to second degree increases the statute of limitations for prosecution from five to six years, increases the basic sentence from three to nine years, and the potential fine from \$5,000 to \$10,000.

Effective date is July 1, 2025.
