BILL SUMMARY

Synopsis:

SB 208 amends the Election Code to provide for qualified elector applying for a hunting or fishing license to register to vote at the Department of Game and Fish.

FISCAL IMPLICATIONS

SIGNIFICANT ISSUES

The Department of Game and Fish reports that it serves hundreds of thousands of hunters and anglers each year. Should SB 208 pass, the state would have another opportunity to reach eligible New Mexicans with election information and register them to vote.

The Secretary of State's Office (SOS) has existing authority in 1-4-48 NMSA 1978 to "designate other state and local public offices to provide voter registration services with the agreement of those offices," and the office is willing to work with the department to establish voter registration processes pursuant to those provisions.

PERFORMANCE IMPLICATIONS

A January 1, 2026 effective date would better provide for the amount of time required to successfully and securely implement voter registration at the department.

ADMINISTRATIVE IMPLICATIONS

Should HB 208 pass, the SOS will have additional administration duties associated with education and compliance. The full funding of the SOS's budget request is necessary to keep up with the volume of work associated with all of the statutory duties supported by the office.
