BILL SUMMARY

<u>Synopsis:</u> House Bill 250 would require correctional facilities to provide free menstrual hygiene products to inmates; requires correctional facilities to develop and implement a policy for issuing such products but outlines some provisions the policy should include:

Menstrual hygiene products should be provided at a level sufficient for the needs of each person in custody who menstruates or experiences uterine or vaginal bleeding, and that these products should come at no cost to the inmate. Allows people in custody the choice between panty liners, tampons and pads or a combination and should be available "on a routine basis and as needed upon request without a medical referral as a requisite." Excludes cases in which "restrictions are strictly necessary to prevent injury to the person or others," and does not further specify when those restrictions might apply — the bill leaves that to the discretion of correctional facilities.

Defines "menstrual hygiene products" as products "used during menstruation or uterine or vaginal bleeding and includes panty liners, tampons in differing absorbances and pads in differing absorbencies."

Inmates within our custody are provided menstrual hygiene products at no charge, ensuring that all individuals have access to essential items for personal hygiene. Inmates also have the option to purchase alternative brands through commissary, allowing for personal preference in product choice.
