# **BILL SUMMARY**

Synopsis: HB 252 amends the Aging and Long-Term Services Act to create the Kinship Caregiver Support Pilot Program. HB 252 contains the following key provisions:

\* Creates a new section of the Aging and Long-Term Services Act

\* Provides direction regarding who is eligible to participate in the program including definitions for fictive kin, grandparent, kinship caregiver, next-of-kin

 $\ast$  Identifies the length of the pilot program, three-years spanning FY26 through FY28

\* Identifies the areas in which the pilot program must be created as

communities within Rio Arriba, Santa Fe, Taos, McKinley and Dona Ana counties \* Identifies the number of participants that should be served in each

community - fifty (50) per community

\* Provides direction regarding services that should be

offered including monthly economic support programs through program partners and provision of access to services or referrals to services to support the caregiver and the children in their care

\* Directs the agency to develop eligibility criteria, an application process, policies and procedures for program implementation

\* Directs the agency to work collaboratively with other state agencies and local agencies in program development and implementation

\* Directs the agency to promulgate and adopt rules to administer the pilot program no later than June 1, 2025

\* Directs the agency to develop the necessary budget to identify the FTE and resources needed to implement the pilot program

\* Directs the agency to provide an annual report to the Legislative Finance

Committee assessing the impact and outcomes of the pilot program no later than December 1, 2025 \* Provides an appropriation of four million five hundred thousand dollars (\$4,500,000) from the general fund to be utilized FY26 through FY28 with any funds remaining at the end of FY28 reverting to the general fund \* Stipulates that this bill be considered an emergency and that it take effect immediately upon passage
