BILL SUMMARY

Synopsis:

This bill creates the **Vibrant Communities Act**, establishing a new program within the **Department of Finance and Administration** to provide funding to eligible nonprofit organizations for public benefit projects.

The bill acknowledges the role of nonprofits in delivering essential services that the state cannot fully support and aims to help them through targeted financial assistance. To qualify, organizations must be 501(c)(3) or 501(c)(12) tax-exempt nonprofits and submit a detailed annual application outlining their project goals, target populations, expected outcomes, and funding needs.

The department will review applications and recommend projects to the legislature for possible funding. If approved, nonprofits will enter into contracts that include compliance requirements, reporting duties, and conditions for fund repayment if project goals are not met.

The program includes strong oversight, requiring annual reports to the governor and legislature on funding amounts and project outcomes. However, the bill's implementation depends on a constitutional amendment allowing the state to provide public funds to private entities for public purposes.
