# **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

Synopsis: HB 319 proposes to amend 17-2-3 NMSA (1978) to exempt domestic strains of quail from the list of protected wildlife species, and to no longer require a permit to raise them in captivity for meat or eggs.

### FISCAL IMPLICATIONS

The Bill would result in an unknown cost to the Agency for: investigating if individual quail are wild or domestic and thus if they were legally harvested; attempting to eradicate escaped and hybrid quail; and managing diseases transmitted from domestic to wild quail.

#### SIGNIFICANT ISSUES

The primary concern is domestic quail that escape or are intentionally released from the captive facility could have significant negative impacts to wild quail populations and to the ecosystem. Having a new species on the landscape will shift the ecosystem balance and impact other species in unknown ways. Domestic quail could establish resident feral populations, becoming an invasive species that could outcompete native quail, causing a decline in native quail populations both locally and statewide. There is a high probability that escaped domestic quail will hybridize with native quail species, which could similarly harm the native populations. Domestic and hybrid species have repeatedly been shown to outcompete native species for food, habitat, and other resources, causing declines in native populations. Further, there is a risk of disease transmission from domestic to wild quail, which could have implications for wild quail die-offs. Declining wild quail populations could lead to a reduction in hunting opportunities.

#### PERFORMANCE IMPLICATIONS

## **ADMINISTRATIVE IMPLICATIONS**

It is unclear who has regulatory authority over domestic quail. This would make it challenging to attempt to control domestic or hybrid quail or implement management activities. It may prove challenging to enforce hunting regulations as it may not be possible to know if quail were shot in the wild or in a private facility.
