Synopsis:

HB370- Establishes guidelines for hospitals granting credentials (medical staff membership or clinical privileges). A hospital may not deny credentials for reasons other than a physician's individual qualifications, uniformly applied to all medical staff applicants and members. Prohibits denial of hospital credentials based on a number of criteria, including economic factors.
